A judge on Friday said he'll need about a week to consider whether a case against House Speaker Bobby Harrell should be handled by a legislative panel instead of in the state's courts. U.S. employers added a robust 288,000 jobs in April, the most in two years, the strongest evidence to date that the economy is picking up after a brutal winter slowed growth. The Labor Department also said Friday that the unemployment rate sank to 6.3 percent, its lowest level since September 2008, from 6.7 percent in March.
