Mr. Poore called the meeting to order and Mr. Bratcher gave the invocation.

On the motion of Mr. Rhodes, seconded by Mr. Gerrard, Council voted unanimously to approve the Minutes of the November 28, 1978 Called Meeting as mailed.

Mr. James Campbell discussed new CETA Legislation and advised County Council that there would be a decrease of \$541,024 in Title VI Public Service Employment funds in Anderson County during the next fiscal year. Council received Mr. Campbell's report as information.

Mr. Mike Mullinax and Mr. Harold Threlkeld discussed proposed annexation of Meadowpark Subdivision to Homeland Park Water District. On the motion of Mr. Gerrard, seconded by Mr. Hooper, Council voted unanimously to adopt a resolution authorizing enlargement of the District, pending approval by the S.C. Public Service Commission of transfer of the water system in Meadowpark Subdivision from Duke Power Company to Homeland Park Water District.

Mr. Richard C. Otter, Mr. Lawrence R. Waltz, and Mr. Ralph Booth discussed a request to transfer the cablevision franchise for the School District Number Five area from Anderson Cablevision to Booth American. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to adopt the Ordinance on first reading.

Mr. Norman M. Walters recommended County Council accept Seminole Point Subdivision into the County road system. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to accept Seminole Point Subdivision into the County road system.

Sheriff E. E. Cooley requested \$8,000 in supplemental funding to provide for an additional Deputy and equipment. Council received the Sheriff's request as information.

Mr. Wilton Mackey requested assistance from Council in providing him with adequate transportation. Council received Mr. Mackey's request as information and the Supervisor stated that he would assist Mr. Mackey in repairing his vehicle.

Mr. Barnette requested \$12,000 in supplemental funding for the Anderson County Planning and Development Board. Council received Mr. Barnette's request as information.

Mr. Hehn presented the proposed amendment to the 1978-79 budget for third reading. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to adopt the Ordinance on third reading with amendments providing an additional \$8,000 for the Sheriff, \$12,000 for the County Planning and Development Board, and \$71,000 for Building Maintenance.

On the motion of Mr. Gerrard, seconded by Mr. Rhodes, Council voted unanimously to adjourn at 10:17 a.m.
