2017 poverty guidelines announced

On Jan. 27, the U.S. Department of Health and Human Services released the 2017 Federal poverty guidelines. The guidelines set the poverty level at \$12,060 for an individual and \$16,240 for a couple in the 48 contiguous states, and \$15,060/\$20,290 and \$13,860/\$18,670 for individuals and couples in Alaska and Hawaii, respectively. We will update the eligibility tables for the Part D Low Income Subsidy (LIS/Extra Help) and Medicare Savings Programs (MSPs) as soon as we receive final confirmation from the Centers for Medicare & Medicaid Services (CMS).

CMS releases MOON instructions

CMS recently released an educational article regarding instructions for the Medicare Outpatient Observation Notice (MOON). No later than March 8, hospitals are required to provide the written MOON notification and oral explanation to Medicare beneficiaries receiving hospital observation services as outpatients for more than 24 hours.
