SOUTH CAROLINA RANKS NO. 25 IN FORBES

South Carolina ranks No. 25 in Forbes' 10th annual [Best States for Business](#), down two spots from last year. Like its neighbor North Carolina, South Carolina has experienced massive net migration into the state over the past five years—resulting in the fifth highest rate in the U.S. The state has been a big proponent of using incentives to lure foreign investment and U.S. companies alike. The Palmetto State's economy also benefits from its status as a right-to-work state. South Carolina has the second lowest union membership as a percentage of its workforce in the country.
