NASHP Releases Snapshot of State of the State Addresses

Governors across the nation have laid out their priorities for the coming year as part of their State of the State addresses. NASHP [summarizes the 44 addresses](#) given to date. A majority of the governors mentioned health care in their speeches, including Medicaid, behavioral health, health care costs, health insurance exchanges, and creating a culture of health. NASHP Releases Summary of 2015 CHIP Directors Survey

Federal funding for the Children's Health Insurance Program (CHIP) is scheduled to expire on September 30, 2015, unless Congress acts. Many state CHIP directors have begun to consider the steps needed should funding remain uncertain or expire. In January 2015, NASHP [surveyed CHIP directors](#) to better understand recent program changes along with state budgeting and planning given the uncertainty of continued federal funding. Many states across the nation are in the process of designing and implementing multi-payer payment reform initiatives. The goals of these initiatives are to improve patient experience, improve the health of populations, and reduce health care costs.
