These issues are clarification of the rural hospital exemption (even though three more hospitals have been exempted), potential implementation of a new payment grouper, clarification of the NICU savings, disproportionate share changes planned for October, and future reimbursement mechanisms. These issues are highlighted on the attached schedule.
