Thank-you, for taking my call, this Executive Order would give Professional Land Surveyors coverage for E&O insurance from the State to volunteer their services during Hurricane Mathew.

At the present time, under current SC Law-SECTION 40 22 295, Professional Engineers and Architects are covered with SC E&O insurance to volunteer their services to the State during the Governor's declared state of emergency, and no pay is involved.

We realized the need to have Professional Surveyors help OCT 2015, and the Surveyors are in the process of proposing a bill for this year's session, in the mean time we need an Executive Order to be able to use Surveyor's in the SC State Guard, assisting state agencies, local governments during Hurricane Mathew.

Coastal Carolina University needs their help with quick response to measuring loss of beach and dunes to assist the state for beach renourishment in Surfside-Garden City program. Many of the Grand Strand beaches are particularly vulnerable being at the end of nourishment cycles. Any help you can provide with is great.

See attached, I have taken the existing law and added Professional Surveyor's so you can take the attached document and make it an order.

Please advise if you need additional assistance with this, and thank-you, for your hard work during this event.
