Rick,

Below are two emails from this morning, one from the upstate and one from the Lowcountry.

Michael:

Hours of Service extention.

As of yesterday both the Belton terminals were out of product and on terminal closed all together. I am running and additional 2 hour per load per driver depending on traffic and extended waiting times to Spartanburg load for deliveries and back. I can use HOS extention to keep up with our business needs.

Note

My drivers typically run 3.5 to 4 loads each from Belton in out allotted time under the HOS rule due to our proximity to Belton. Loading Spartanburg can add 6 additional hours to a driver day

under these circumstances- Increased travel and longer wait at the terminal.

Michael

Yes there are issues with supply along the Colonial pipeline, especially along the spurs like N Augusta. As an example, many major oil companies are diverting us to Spartanburg or Charlotte from N Augusta (Exxon is down to 35% allocation in N Augusta).

The pipeline is reportedly going to restart on Thursday, however the shipping cycles have been interrupted so we will see outages for the next 7-10 days until inventories can get caught up.

As for HOS, carriers will need some relief.
