President-elect announces choices for HHS, CMS

President-elect Donald Trump has nominated Rep. Tom Price (R-GA) to lead the Department of Health & Human Services (HHS) and Seema Verma as administrator of the Centers for Medicare & Medicaid Services (CMS). Price, who must be confirmed by the Senate, is chairman of the House Budget Committee and has played a key role in developing legislation to replace the Affordable Care Act (ACA). Verma is best known for helping Vice President-elect Mike Pence design Indiana's Medicaid expansion under the ACA. NCOA and other aging advocates are concerned that Price is a strong proponent of repealing the ACA, replacing Medicare with vouchers, and turning Medicaid into a block grant program—changes that would likely impact seniors' access to health care and increase their out-of-pocket costs.
