Description/Significant Features:

The single-story, four-bay, three pile frame Period Cottage is clad in asbestos siding and rests on a continuous brick foundation. Resting atop the building's side-gabled roof (on the facade) is a shed roof dormer, featuring two windows which have been enclosed. The building is accessed by an original wood door featuring vertical raised panels topped with glazed arched panes. A modern metal awning supported by wooden posts frames the facade's right two bays. The building appears to retain its original three-over-one light windows and window surrounds on the first floor. Original paired one-over-one sash on found on either gable end. An interior brick chimney rises from the roof ridge.
