Dear Mr. Keek:

The purpose of this letter is to inform you that the Health Resources and Services Administration (HRSA), has recertified Genesis Health Care Inc., for continued Look-Alike status as a Federally Qualified Health Center (FQHC). The HRSA review and recommendation for recertification is based on the qualification criteria set forth in the Intra-Agency agreement of December 31, 1992, between the Centers for Medicare and Medicaid Services (CMS) and HRSA.

Genesis Health Care and the sites listed below are considered FQHC look-alikes, with respect to Medicaid coverage and payment. The recertification period for Genesis Health Care, Inc., is September 21, 2011 through September 20, 2012. Please note that reimbursement covers only nonsectarian health services within the scope of Medicare and Medicaid, as appropriate and that cost reports must not include time devoted to religious activities.

Genesis Health Care is providing comprehensive health services to the medically underserved areas of the Pee Dee area of South Carolina. Genesis Health Care is serving approximately 27,902 patients, 14.1 percent of whom are Medicaid recipients.


