Changes to Agencies:

- Department of Education: various and sundry corrections
  - Cool
- Lottery Expenditure account – sheet complete
  - Cool
- USC – Columbia. Deleted EIA-related lines that we did not fund this year.
  - Cool
- **Health and Human Services**
  - **We're out of time. I wrote up a super-short blurb that's a fill-in-the-blank exercise.**
- Department of Mental Health – added back \$670,000 in double-counted base reduction. The new number is updated for use in the healthcare chart.
  - OK...I have a v03 of that chart now, but can't finish it until there's an HHS number.
- **DNR – I am going to reboot this entire agency. There shouldn't be more than about \$50k in difference on the general fund; we have just moved so much around that I want to start from scratch**
  - OK
- **PRT – let's talk a bit about intent and reallocationsno GF Change.**
  - OK
- Conservation bank – no, the proviso is no longer necessary because the statutory trigger had been met to fund the bank. IDEA! What about a proviso that limits the ability of the bank to obligate funds beyond a BEA certified amount. Accompany this with a proposed statutory change. We could also think of a limit on administrative fees making the overall authorization irrelevant.
  - Too late for new ideas. Deleting the existing proviso, though.
- **SLED – Allocations that we're likely not going to accept.**
  - **We can discuss in the morning, but I think we're out of time for more changes. Certainly the other stuff's a higher priority.**
- **PPP - I need to talk with their budget manager first thing AM. I have continued doubts about their personnel allocations.**
