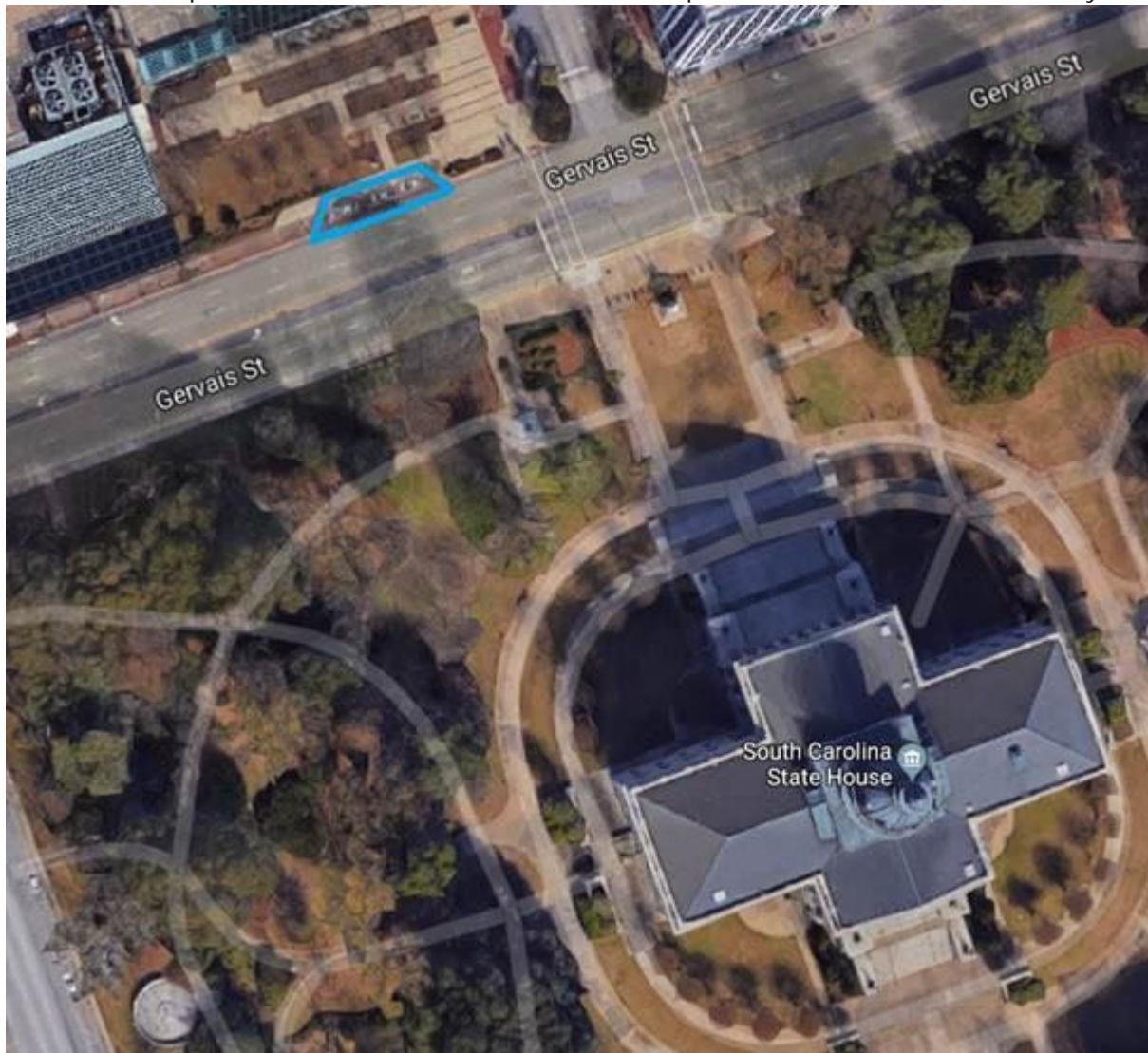

Good Afternoon,

The C-SPAN Bus is traveling across the U.S. to all the state capitals in celebration of the bus being on the road and reaching out to people all across America for the past 25 years. As part of our drive across America, our goal is to get as many governors, lieutenant governors & cabinet officials as we can on the morning call-in program, [the Washington Journal](#), while the bus (which doubles as a mobile studio) is stopped outside the capitol building. Having said that, I wanted to see if Lt. Gov. Bryant would be available for an interview.

For this interview, we'd be looking for 20-30 minutes of Lt. Governor Bryant's time on Thursday, January 25<sup>th</sup>. We could do it anytime between 7-10a ET.
