Today is the fourth time that I have wrote you from Aiken County jail. Today, Father's Day, I would have spent the day with my six girls + twelve grands. Today is 55 days I have been here. If I am here legally, then I must accept it. Every source I've talked to says I am here illegally. As you know I have been in the S.C. Penitentiary three times illegally + County jail 4 times, for this exact charge of a felony. Also I have never been served with a warrant, never arrested never arraigned, never given notice nor read my constitutional rights. You see that would be many (5 alone) constitutional rights violated. A felony hung over my head from Oct 22, 2001, at Paul Bush's Kangaroo court, in Allendale until Sep of 2011, and after ten years, the S.C. Supreme Court, finally ruled that Judge Bush acted illegally charging me with a felony, at most it could have been was a misdemeanor. This high court also ruled that Ronald Summers letter to me had zero (0) value. My family spent near four million \$4,000,000.00 dollars fighting to preserve my constitutional rights and their lives, went through hell for over ten years, over all from 1996 to 2012 when I got out, would be 16 years. The state of S.C. never made any apology, then the Supreme Court allowed Judge Roger Young to sentence me, I made 8 months 10 days, gave me supervision + 500 hrs of community service even after the probation recommended I only make some probation. I have been working ^{2 OFFICER} on a series of books that will be on the market within a couple years. The title of two are Modern Day Kangaroo Court Live in S.C.
