The Export-Import Bank is the subject of the latest battle between business and conservative factions within the House Republican Conference, two sides that take dramatically different views on the bank's value. But at least 15 Republican governors — including at least one considering a run for president — are siding with business interests in urging Congress to reauthorize the bank.

Note: South Carolina Gov. Nikki Haley (R) sent her own letter earlier this month, along with Sens. Lindsey Graham (R-S.C.) and Tim Scott (R-S.C.). Boeing, which has a major plant in Charleston, S.C., is one of the top recipients of Export-Import Bank aid.
