**Good Afternoon Mr. Morris and Mr. Dickerson,**

I wanted to thank you both for your site visit to the Central Midlands AAA, meeting with my staff and providing insight to future objectives and goals from the Lt. Governor's Office on Aging. Speaking for myself and staff, we're very excited and look forward to the future and continue efforts serving our seniors and the disabled population.

During your visit I was provided maps and section 8 housing locations, along with the senior center sites in each of my four counties. While I knew my contractors were providing services to Section 8 housing, the number of clients and by location was not readily available to me. I immediately reached out to my contractors asking them inform me of their efforts in serving this population.

Please be advised that I can not speak for several of the sites in Richland County, as they are not under contract with me and have several exceptions to their services. They are:

The Antioch Senior Center, charges \$3 per day for breakfast & lunch. They serve between 8-25 seniors Monday-Friday. Their maximum capacity is 40. I spoke at length with Barbara Mickens (Director). She did try to seek funding several years back from the LGOA, due to finding the requirements too restrictive. The Antioch Center receives funding from City of Columbia, Richland County, UPS (every other year), donations and state funds thanks to their Rep. Howard. Through their missionary, they serve 4 couples on HDM, of which Ms. Mickens uses her personal car for delivery. They'll also temporarily serve a client from the day program whom has fallen ill and wants HDM.



The Senator Isadore Lourie Center does not provide congregate meals, or HDM. Seniors have to pay a membership fee (more like a club) and most activities are social and for a higher-level income client. The new director, replacing Mary Kessler, is Sandra Ownsby and she's my neighbor. We've spoken at-length and Mrs. Owensby did run a senior center in Spartanburg before coming to the Lourie Center. They'll do a pot-luck luncheon for certain activities during the week.

The senior center called Dream Keepers offers a group of 25 seniors three times a week health training, life skills training, and cultural events that promote independent living. No meals or transportation.

The local Shepard's Centers offer certain extended classes (6 weeks) with lunch for \$37. There are limited number of scholarships available. There are classes 3 times daily only on Thursdays, with lunch for \$8.50 unless it's sponsored and then discounted for \$2. Senior must be self sufficient. No transportation is provided. Spoke with Kay Mitchell, Chairman of the Board, she stated that the Shepard Centers are not senior centers. It's a totally volunteer organization, seniors serving seniors, through donations. Shepard's Centers do not receive state or federal funding.

## **Fairfield**

Fairfield COA picks up 3 clients from Laurelwood Ct. One additional client wants to come, but has not fully committed to being picked-up. Not all clients are mobile due to poor health conditions. FCCOA delivers 13 HDM to Laurelwood and the rest (64) are in Adult Daycare and are not appropriate for senior center level. And they receive services under CLTC. Both site managers/social workers are aware of the services offered by FCCOA.

## **Newberry**

These may not be absolutely true numbers as it is not a question on the AIM assessment. It was a question on the AIM assessment, but has been removed.

## **Lexington**

Yes, LCRAC are serving a good many people who either live in HUD apartments or who have Section 8 certificates for other apartments/homes. Some are congregate and some are HDM. LCRAC does not face any barriers in serving them. LCRAC has established working relationships with the managers and work well together. HUD clients have to meet the same qualifications as any other person requesting services. Those who are able to, attend a center and those who are



home bound receive HDMs. The issues LCRAC faces are the same as with any client – not home to receive the meal, failure to cancel, etc. There is nothing that is unique to living in HUD housing.

Staff and volunteers like delivering/picking up at apartment complexes as they can assist multiple people with one stop rather than driving miles between clients.

Many who live in Section 8 units are also on CLTC. We serve some of the CLTC clients HDM, some have other meal providers. LCRAC has no way of providing information on the ones they don't serve, nor have any way of knowing if some of them go to an adult day care program.

LCRAC has served clients from Hampton's Crossing, Pebble Creek, and Scarlett Oaks in varying numbers over the years. LCRAC's most recent Hampton's Crossing client just passed away. LCRAC currently serves 2 GDS clients from Pebble Creek and 3 HCM and 2 GDS from Scarlett Oaks. These are far from the only Section 8 clients in Lexington County. LCRAC serves 2 HDM and 2 GDS from Elm Street Apartments in Swansea. LCRAC also serves a good many who have Section 8 certificates and rent from private landlords. Services for some are funded through the LGOA and some with LCRAC funds. In order to obtain the above information it entailed calling the centers and asked them for numbers.

Mr. Morrison, I hope this information has been informative and helpful in serving our seniors and the disabled population in Richland, Lexington, Newberry and Fairfield counties.
