SECTION 1: The Minutes for the meeting of January 17, 1991; copies of which have been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion accepting monthly reports as published by the Department of activities for the month of January, 1991.

SECTION 3: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$1,000.00 during the month of January, 1991, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to advertise for and select a consulting firm to provide engineering design services for improvements to North Rhett Avenue in Berkeley County, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving supplemental agreement number 8 to provide additional engineering design services for vehicle weigh-in-motion stations in Dorchester, Greenville and Spartanburg counties, in the amount of \$95,000.00, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to enter into Supplemental Agreement No. 2 with The LPA Group, Inc. for additional services on the US Route 25/US 123 Interchange Improvement in Greenville County, in an amount of \$450,000.00, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the action of the Department in entering into a supplemental agreement with the Joint Venture of Deleuw Cather/LPA Group to provide a draft environmental assessment for the US Route 521 widening project in Williamsburg and Georgetown counties, at an estimated cost of \$1,043,960.00, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion authorizing the City of Rock Hill to enter into a supplemental agreement with The LPA Group/Campco Engineering for additional engineering services required for multilaning SC Route 161 in York County, at an estimated amount of \$2,365,000, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion authorizing the Department to enter into a contract with Barton Protective Services to provide security services for the headquarters' building, at an estimated cost of \$65,000.00 per year, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion authorizing the reduction and transfer of the allocation of State Highway funds for capital improvements/land and buildings, as shown in detail in the Appendix.
