ENTERPRISE ZONE PROGRAM

The Job Development Credit (JDC) allows new and/or expanding companies to reimburse themselves for capital expenditures associated with new jobs and investment. The source of funds is payroll withholdings, and the potential value of the JDC depends on the number of new full-time jobs created, rate of pay and the county in which the company is located.

A Retraining Credit allows existing South Carolina companies to receive up to \$500 per year/per employee, not to exceed \$2,000 over five years, for the purpose of retraining *production* employees. The company must match, on a dollar for dollar basis, the total employees withholding share used for the training. Additionally, the training must be approved by and coordinated through the local technical college.

FOREIGN-TRADE ZONE Nos. 21, 38, 127

Foreign-Trade Zones (FTZs) are essentially areas on U. S. soil or near a Customs port of entry, where foreign and domestic merchandise is considered to be in international commerce, and operated under public utility principles. Foreign or domestic merchandise may enter the zone site without a formal Customs entry or the payment of Customs duties or government excise taxes.

Some 2,800 U. S. companies, which employ 316,000 people, 70 percent of which are small businesses, are using FTZs to improve cash flow through deferral of duty, for duty avoidance on exported merchandise, and to reduce or eliminate import duties by assembling or manufacturing in a zone. Other potential benefits of FTZs include faster drawback of duties, the ability to borrow against goods stored in the zone, lower insurance costs, and holding merchandise until quota windows open. Companies who locate in general-purpose FTZs or subzones may sample or inspect, store, re-label, repair, display, assemble, manufacture, process, destroy or perform other value-adding services to goods while reducing duty expenditures.

IMMIGRATION AND NATURALIZATION, UNITED STATES, EMPLOYMENT ELIGIBILITY CONFIRMATION PILOT PROGRAM

The Commissioners of the Immigration and Naturalization Service (INS) and the Social Security Administration (SSA) began a four (4) year *Citizen Attestation Pilot Program* in late 1997. During the pilot, the INS will verify employment authorization electronically for all newly-hired alien employees for businesses participating in the program. Employers in all states (including the District of Columbia, Puerto Rico, Guam, and the Virgin Islands) are eligible to the pilot program. There is no charge to businesses that apply to participate in the program. Businesses requesting participation will need a personal computer with a modem to make inquiries. A brochure which describes the program and Election Form (OMB No 115-0217) to apply for the program is available at the SC Department of Commerce, Division of International Trade and Existing Business.

This Fact Sheet provides information on the Jobs Tax Credit, a tax incentive available under certain conditions to new and expanding companies where new employees are being added. The credit is allowed for companies engaged in manufacturing, processing, warehousing, wholesaling, research and development and service related industries. The tax incentive is a dollar amount per new employee that is applied against corporate state income tax.

Companies should file Form SC 616 (Application for Certification of Eligibility for SC New Jobs Credit) before the end of the calendar year in which the expansion is planned or announced.

WORKERS' COMPENSATION COMMISSION, SC

The South Carolina Workers' Compensation Commission is responsible for the enforcement of workers' compensation laws and regulations and resolves disputes when claims are contested. Every employer with four or more employees--there are some notable exceptions such as agricultural employment --is required to purchase workers' compensation insurance or be approved by the Commission to self-insure their risk. Workplace accidents are reported to the Commission to ensure oversight for proper and timely payment of benefits, but all claims are managed and paid by the responsible insurer. The Commission provides workshops and printed materials for those who want more detailed information or reference the agency's web site (www.state.sc.us/wcc/) for a more complete description of the workers' compensation system in South Carolina.
