Haley, I hope that you will personally receive this letter after it has been through so many hands by your  
screeners and staff. Several things before the reason for my letter. First, my wife, Carol, and I are supporters of

yours and voted and supported you locally here in York County. We also thank you for the nice Christmas card from you and your family. My reason for writing is the breach in the South Carolina Department of Revenue (CDOR) that occurred several months ago. We were both notified on January 25, 2013 that our tax records were compromised. We appreciate that additional technology is being implemented by the State to prevent further compromise, but the original compromise will keep us financially exposed for years. The letter we received last week recommended we take an approach that is good only for one year. This is my problem and concern. This is like our Federal Government telling the Taliban that we will pull out of Afghanistan in a year. You are basically telling our Cyber enemies that our identity protection will be good for only one year. This will be like a ticking time bomb for us for years. The State should take the position of at least extending this free protection for a minimum of five years to those citizens who have become potential victims because of this compromise. A free one-year protection plan as outlined in last week's DOR letter is really a cop out by the State on the need to protect your taxpayers due to this oversight. Thank you for allowing two of your Fort Mill supporters to voice a difference of opinion to the State's approach to helping protect us from its errors.
