Please know that the Continuum wants to work with you to support Kaitlyn, you and your family in her transition home. Your service coordinator, Ms. Pruitt, is working to have family support services, crisis management and behavior modification services in place on her return home. She is also coordinating psychiatric care through Sumter Family Health Center, individual therapy with Fuller Life Strategies and working with school personnel to prepare for Kaitlyn's return. Ms. Pruitt will be in touch with you soon to schedule a Wraparound Team meeting to identify other needs that should be addressed.

My daughter is 9 years old she's adopted, we have had her since she was six months old. I could tell you her entire life story but it would be like writing a book. So as of today 3/21/2014 my daughter resides in Three Rivers Behavioral Health in Columbia SC. She was placed there on 12/19/2013 by recommendations of continuum of care, Darlington county school district, and her psychiatrist. The doctor at three rivers states my daughter is not ready to be back at home and needs to continue her treatment however continuum of care says she is to be discharged on April 2, 2014. I am begging and pleading if you can do anything to help my daughter continue treatment at Three Rivers as the doctor has told continuum of care she needs it would be appreciated. I am willing to come and sit down ! and share all medical records and documents stating her problems.
