BACKGROUND ON ELEANOR MCMAKIN :

The student's name is Eleanor McMakin. She is an exceptional 5th grade student at A. J. Whittenberg Elementary School of Engineering.

To be selected to attend the Rotary luncheon with the governor, 5th grade girls were asked to write a letter stating why they should be chosen. This was done to celebrate Women's History Month (March), especially as Gov. Haley is the first female governor in the state's history.

Eleanor's letter was a stand out. She is highly articulate and well aware of current events for someone her age. She was the first to turn her letter in for the contest. She's extremely excited to have the opportunity to shake hands with Gov. Haley and to hear her speak at Rotary tomorrow.

Thanks again for this opportunity. I know Eleanor will remember it for the rest of her life.

GOAL: Gov. Haley will address the Rotary Club of Greenville to rally opposition to the House budget which contains a 15 year, \$500 million increase in debt.

SUGGESTED TALKING POINTS

State/Greenville Economy

- South Carolina is clearly moving in the right direction
- Last year was a record breaking year for the number of people working!
- Between January of 2013 and December of 2014, the number of South Carolinians employed increased by 75,000!
- Here in Greenville County, the success has been tremendous.
- Since 2011, the unemployment rate in Greenville has decreased by 3.4 percent – from 8.4% to 5%!

- We've announced over 5,000 jobs and over \$940 million in capital investment!
- That's real progress – every time we bring a new job here, we help a family.
- But we're starting to see some problems in Columbia that could hinder this progress, and I need your help to make sure that doesn't happen.

House Budget

- One of the things I want to talk about is the House version of the budget, which is really troubling.
- This year, our revenues are projected to increase by nearly \$300 million (\$288 million recurring revenue increase).
- Not only did the House spend all of that, they also included nearly \$500 million (\$498 million) in debt on the state's credit card.
- Since day one of my administration, we've worked hard to lower our outstanding debt! And it's been successful.
- Between 2011 and 2013 (the latest data available), the state's total outstanding General Obligation debt decreased by 16% (from \$1.035 billion to \$865 million)
- The House's budget would completely undo the tough decisions we've made.
- Rather than keeping some debt off the state credit card, the House decided to put nearly **\$500 million back on the credit card.**
- That's almost \$800 million in additional spending this year.
- That's not the South Carolina I know. We've long taken pride in fighting to be a low-tax, low-debt state, holding onto our credit rating through long-range planning and fighting to prioritize budgets.
- This week there will be a vote on an amendment to strip the \$500 million in debt from the budget. I urge each and every one of you to contact your state legislators and tell them to strip the \$500 in additional debt out of the budget!

House's Transportation Plan

- Not only did the House increase spending by nearly \$800 million, members of the House are also considering a transportation bill that would increase taxes without a significant offset.
- So certain members of the House are saying they need to use all of the natural growth in revenues, an additional \$500 million on the credit card, and then they're telling citizens that they don't have enough money to fix the roads!
- This is a totally unacceptable way to govern. I urge you to contact your legislators and tell them not to support H.3579 because you don't support a net tax increase.
- All of us acknowledge we need to do something about transportation, but there's a right way and a wrong way to do it.

- That's why I announced a plan to revitalize our transportation system and make the state more competitive in my State of the State Address – a plan that calls for the largest tax cut in South Carolina history and the largest single investment in our roads system we have ever seen.

Tax Cut/Transportation Plan

- We are currently competing for jobs and investment with states around the country, specifically our neighbors in North Carolina and Georgia. But we're also competing internationally - with countries all over the world. So it's imperative that we do everything we can to continue to attract companies and create the most business-friendly environment we can.
- Tennessee, Florida and Texas have no income tax at all. Georgia's income tax is a full percent lower than ours, and North Carolina just recently cut their income taxes by 2 full percentage points.
- By cutting the income tax rate from 7% to 5% incrementally over the next decade, we would improve our tax competitiveness from 38th nationally to 13th.
- By doing this, our income rates would be lower than North Carolina and Georgia and anybody you ask will tell you that this would be a major draw for jobs and capital investment.
- Likewise, it will put money back in the pockets of South Carolina's citizens where it belongs and not into the hands of tax and spend politicians.
- We also have to restructure the transportation commission. The condition of South Carolina's roads is driven by parochial politics and horse trading. We can no longer have a system where individuals are only representing the best interest of specific parts of the state. How and where money is spent at DOT should be based on the needs of the state in its entirety, making sure that everybody is represented equally. That's why I have called for the elimination of the commission.
- Finally, we suggested an increase to the gas tax by 10 cents over 3 years, dedicating all additional revenue to improving our roads.
- By increasing the gas tax by 10 cents, it will keep our gasoline tax below both Georgia and North Carolina's.
- There are some who want to just raise the gas tax without cutting the income tax. It's true we have the 3rd lowest gas tax in the country. But as I've said multiple times – I will veto any straight up gas tax increase.
- If all we do is increase gas taxes, it will put the brakes on the positive momentum we are seeing in the economy.
- As I made clear in the State of the State – this package is a 3 part deal. We need to cut taxes, restructure the transportation commission, and increase the gas tax.
- And like I said before, if the legislature gets on board with this plan and passes it, it will result in the largest tax cut in South Carolina's history.
- If we take these 3 steps, we'll improve our transportation system and build on the competitive

- advantages that we've seen result in so much economic growth.
- But running up the credit card and then increasing taxes is the wrong way to go. That's why I'm asking you to raise your voices in opposition to the more debt and higher taxes.

ANSWERS TO RECENTLY ASKED QUESTIONS ON TAX REFORM PLAN:

- What this tax plan means is an average of \$689 dollars a year back in the pockets of taxpayers – about two weeks take home pay for someone making \$30,000 per year.
- In terms of what this means for our families, 50 gallons of gas to drive from Greenville to the beach, get around town and drive home will have a \$5 impact on your wallet. Our tax cut means \$689 back in your pocket, which pays for that entire trip.
- Ten cents for roads means we start turning our highway system around next year. It means \$394 million a year to roads that meets the \$208 million we need to stop the decline of our pavements and bridges and adds over \$180 million per year to actually start improving our highway system.
- Our priorities are clear – with a Secretary accountable to your governor, we're going to focus on the roads our people rely on to get to work, the roads our businesses need to move their goods, and the roads our visitors need to enjoy our state from the mountains to the sea.
- No more commissioners fighting over roads money for their districts and their contractors. Instead we'll have a Secretary that fights for the entire state; a secretary with one boss and one goal – rebuilding our highways.
- There is talk out there that this tax cut will hurt programs, hurt schools. That's just not true. Our long-range projections would put our state's General Fund at over \$10 billion dollars – more than \$3 billion dollars larger than it is today – without this \$1.7 billion annual tax cut. What we're saying is, invest in schools, preserve our roads, help out law enforcement, but slow the growth of government when it comes to things we don't need. We can do both – it really is a win-win.
