**Capital Punishment, DSS, and Civics -- Update from Sen. Tom Young -- March 24 to March 30, 2015**

The legislature is in session Tuesday, Wednesday, and Thursday between now and early June. I hope that you find this update helpful and informative. If I can help you with an issue, please let me know. Thank you for the opportunity to serve you in the South Carolina State Senate.

**State Government News**

**Roads Bills Advance:** Last week, the majority of both the Senate Finance and the House Ways and Means Committees voted in favor of moving forward road bills pending before their respective committees. The Senate bill passed the Senate Finance Committee on Wednesday night and a motion was made on Thursday to set the bill for "special order" meaning it would be given priority status for debate by the full Senate. I voted against setting it for special order. Governor Haley has said she will veto both bills as they currently are written. To learn more, go [here](#).

**DSS Oversight Report Released:** Last Wednesday, the DSS Oversight Subcommittee that I chair released its report as to how DSS and the General Assembly can improve child protective services in our state. **Capital Punishment and Lethal Injections:** In South Carolina, an inmate on death row can choose to die from the electric chair or by lethal injection. The last execution in our state was in 2011 and there are 44 people on death row in South Carolina. The state uses pentobarbital as one of three drugs administered in lethal injection. Recently, the Dept of Corrections (DOC) announced that it no longer can get pentobarbital due to the manufacturer's concern of public back lash for supplying the state with the drug. The DOC proposed that South Carolina do like other states with a similar issue: Pass legislation to protect the identity of the manufacturer just like the identities of others on the execution team are not released. Last Thursday, the Senate Corrections and Penology Committee deadlocked at 7-7 on whether to advance the bill. I voted in favor of advancing the bill as I view it as a possible solution to a problem that is preventing our state from carrying out sentences for death. I expect this issue to come back up again later this spring. It is important that we develop a solution so that the sentences can be carried out.

**Body Cameras for Law Enforcement:** Last week, I sat on a Senate subcommittee taking testimony on a bill that will require all law enforcement agents to wear a body camera while performing many of their daily tasks in dealing with the public. There will be more testimony on this bill over the next few months. I do not expect any movement on this bill this session. Currently, some law enforcement agencies, like North Augusta, have decided to implement the use of body cameras. Others are weighing the costs to their agencies. I am not for mandating that all law enforcement agencies must use body cameras and prefer leaving the decision up to the agency especially since the costs will be borne by the law enforcement agency.

**Mailer for Senate Bill 277 -- Local Phone Lines:** Many people in our senate district received a mailer requesting that I support Senate Bill 277. The mailer says that if the bill is passed, then it may lower landline phone bills. The mailer did not specify by how much. I am studying this bill. My understanding is that if the bill is passed, then landline phone bills may go down around 25 cents a month while cell phone bills will go up about 25 cents a month. The bill involves the state universal

service fund which exists to ensure the availability of landline phone service throughout the state.

First established by state law in 1996, the state universal service fund establishes a system by which customers pay a surcharge on the land line phone bill to support local telephone companies. I am studying various aspects of this legislation and have not yet decided how I will vote on the Senate floor as I am still trying to understand all of the issues involved with it.

**Wild Turkey Hunting Season Changes:** Aiken County is home to many turkey hunters. Last week, the full Senate gave final approval to legislation which changes the turkey hunting season statewide for hunting male turkeys to March 20 - May 5 and sets a uniform statewide season bag limit per hunter for male turkeys at 3. The bill also provides for a statewide youth weekend for adults to take a child turkey hunting in mid March. Currently, the turkey season for all game zones in the state is April 1 through May 1 except for Game Zone 6 which starts March 15. The changes begin next year in the 2016 season.

**Civics Education Passes Senate:** Currently, South Carolina's high school students are required to take a course in United States government. Last week, the Senate passed legislation that will require students in those U.S. government classes and those pursuing a GED certificate to take the 100 question test that is given to applicants for U.S. citizenship. Students who pass may be recognized by the school district if the district so chooses and the percentage of students from each school who pass must be reported to the S.C. Education Oversight Committee. The requirement goes in place for students entering the ninth grade in the 2016-2017 school year. The bill now heads to the House.

**Mental Health Court Diversion Program:** Last week, the Senate passed legislation expanding mental health court programs in the judicial circuits. The concept is to allow individuals who have committed non-violent offenses because of a mental illness to be diverted from the criminal justice system and into a mental health treatment program. - Completion estimated for 2017
