Celebrating 50 years of Medicare and Medicaid with a New Advocate Resource

In celebration of the 50th anniversary of the day that two of our country's most successful anti-poverty programs became law—Medicare and Medicaid—we released a special toolkit for advocates of [dual eligibles](#) (the 10 million low-income Americans who receive care and services under both programs). Five years after the Affordable Care Act provided a renewed focus on coordinating the two programs through demonstrations, states and the Centers for Medicare and Medicaid Services (CMS) are in the early stages of evaluating the demonstrations. To contribute to these efforts, we created [The Dual Eligible Demonstration at Five: Justice in Aging Toolkit on Design and Implementation](#). The toolkit is a compilation of a [brand-new tool](#) comparing different state outreach materials and resources, and materials for advocates that we developed earlier.

Justice in Aging at WHCOA

Justice in Aging Staff Attorney Fay Gordon attended the [2015 White House Conference on Aging](#) on July 13. This once-a-decade conference touched on the struggle low-income seniors face in accessing quality health care, and the lack of economic security experienced by many. Conference panelists discussed the need to provide caregivers with a functional, navigable, long-term services and supports system, with expanded home and community-based services. An absence of specific policy proposals emphasized the need for advocates and legal services leaders to remain dedicated to working together to address the multiple challenges facing low-income older adults. Justice in Aging Submits Comments on Medicaid Managed Care Regulations

On May 27, the Centers for Medicare and Medicaid Services (CMS) released a proposed rule to update the Medicaid managed care regulations for the first time in over ten years. To aid advocates in preparation of comments, we released an issue brief, [Medicaid Managed Care Rules: Key Considerations for Aging Advocates](#), which breaks down the key areas of importance for older adults and their advocates. We also [hosted a corresponding webinar](#), which explored eight key areas and what they mean for long-term services and supports and older Medicaid beneficiaries.

CUFF Act Put to Bed—for Now

Mid-way through June, Social Security and SSI benefits were on the Congressional chopping block as an offset for a transportation bill. We mobilized our network on this issue and you responded by contacting your representatives and delivering the message loud and clear: we should not finance highways by cutting off Social Security and SSI benefits to the low-income seniors and people with disabilities who need them the most. Thankfully, we were able to build enough opposition in the Senate to get the Social Security and SSI cuts removed from the transportation bill. However, cuts to these vital programs, transparently mislabeled as the [CUFF Act](#), are likely to be proffered again as offsets on other bills in this Congress. **Please watch your email for future action alerts from us.** Thanks for

The interview was a chance for us to weigh in on the importance of Social Security in the lives of older Americans, and outline some modest proposals to maintain and expand the program. With more and more seniors aging into poverty, it was a welcome chance to shine a spotlight on the burgeoning inequality crisis.

Senate Reauthorizes the Older Americans Act

On July 16, the Senate passed the Older Americans Reauthorization Act of 2015, which reauthorizes funding for dozens of programs and services older adults and their families rely on. The Reauthorization Act continues funding for crucial programs like Meals on Wheels, family caregiver support, and elder abuse prevention training. The bill is now awaiting approval by the House.
