If you are asking if the Code of Laws was updated online this week, yes it was. As for effective dates though of particular legislation passed last session, you need to look at the specific code sections involved and the history line will give you the effective date. Most things take effect upon signature of the Governor even though the Code is updated online in December or January of each year. I do know that some tax provisions had an effective date of January 1, 2016, if that could be what you are looking to confirm.
