The Savannah River Site's liquid waste contractor used its Liquid Waste System Plan to outline funding as the reason why it will not meet tank removal deadlines. Savannah River Remediation, or SRR, released Revision 19 to the plan back in May.

**Note:** Officials have often noted that closing the tanks are a top priority, including Gov. Nikki Haley who has regarded the liquid waste as the biggest threat to environmental health in the state.
