Associated Press: Haley: Feds have left South Carolina in dark on Guantanamo

Gov. Nikki Haley on Thursday criticized the federal government for keeping her in the dark about plans to potentially transfer Guantanamo detainees to South Carolina, telling a U.S. House panel that she has heard no details about what she says could be detrimental for her state. "They've handled this very much on their own and have not included us in the process," Haley, a second-term Republican, told a U.S. House Homeland Security subcommittee examining the implications of moving prisoners to certain communities. Haley has been outspoken in her opposition to transferring the 80 remaining detainees from the prison in Guantanamo Bay, Cuba. On Thursday, she told lawmakers that Defense Department officials surveyed the Naval brig 15 miles from Charleston but have said nothing about whether they still considering bringing prisoners there.

South Carolina Gov. Nikki Haley came to Washington, D.C., on Thursday with one clear message – keep Guantanamo detainees out of South Carolina, and if you need extra money to keep the prison open I'll help you find it. "You could pay the state of South Carolina to host these terrorists, and we wouldn't take them. For any amount of money," she said in her testimony before a House Homeland Security subcommittee on the local impact of transferring prisoners from the facility in Guantanamo Bay, Cuba. "Imagine my surprise," she said. "Not only was it against federal law (...) but why would anyone want to put terrorists in Charleston?"

Guantanamo Bay and the shootings at Emanuel AME Church were both subjects of debate Thursday when Gov. Nikki Haley was on Capitol Hill to argue against relocating prisoners from the Cuban detention center to the Naval Consolidated Brig Charleston. Invited to testify in front of the House Homeland Security Subcommittee on Oversight and Management Efficiency, Haley said Charleston had already been through enough to be forced to share a ZIP code with suspected terrorists. "Last summer the people of Charleston stared hate directly in the eye. We know true hate, and we know what real fear feels like," Haley said in her opening remarks. "We don't need to see it again, nor do we wish it on any other state. Keep the terrorists where they are, where they belong. Don't bring them to my home."

Note: Haley did not take the bait when Democrats on the committee asked her to explain why it is more dangerous to house international terrorists than to house Dylann Roof, the alleged perpetrator of the deadly church shooting last year.

Relocating terrorist detainees from Guantanamo Bay to the U.S. would create a new domestic target for terrorists and probably wouldn't save taxpayer dollars, South Carolina Gov. Nikki Haley told Congress Thursday. Haley told members of the homeland security subcommittee on oversight and management efficiency that Obama's goal — to eliminate Guantanamo Bay as a propaganda tool for terrorists — is futile. "This line of thinking is giving these terrorists too much credit and too much validity," she said. "Terrorists do not need a jail to hate us. They hate us on their own."

"It makes zero sense."

Gov. Nikki Haley wrapped up testimony in Washington, DC about her concerns over the possible transfer of Guantanamo Bay terror suspects to sites in this country, including the Naval Brig in Hanahan. The hearing before the U.S. Homeland Security Committee is addressing the potential impact on the Palmetto State's future of moving potentially dozens of Guantanamo detainees to United States. Haley said one of the concerns is the economic impact of moving detainees here to South Carolina.

Note: "How am I to tell these companies that they will be sharing an address with the most heinous and dangerous terrorists on earth -- that the city that they chose to call home is now going to be one of the most high-profile, terrorist targets in the world? The truth is -- I can't and I won't," Haley said.

Haley, a rising star in the Republican Party, told members of a House Homeland Security subcommittee that proposals to bring suspected terrorists to the Naval Consolidated Brig in Charleston, S.C., would dramatically affect the local economy, make the community vulnerable to extremist violence and cast a shadow of fear over the public. "You could pay the state of South Carolina to host these terrorists and we wouldn't take them for any amount of money. There is no price," she claimed. "What company is going to invest in a state where they keep these heinous terrorists? They're not going to," Haley added. "Who's going to come vacation in a state that is now known to house these terrorists?" There are 80 detainees remaining at the U.S. prison at Guantánamo Bay, Cuba. Of those, 46 have been deemed too dangerous for release.

It's "the city we call the holy city," "the number one vacation spot in the country," "the friendliest state in the union," "the most patriotic state in the Union," Haley told members of the House Oversight and Management Efficiency Subcommittee. "Why would anyone want to put terrorists in Charleston?" The South Carolina governor then switched to a more somber note. "We looked hate in the eye last year," she said, referring to the shooting by a white gunman, who killed nine people at a historic black church in Charleston. "Our state is still recovering from that." Homeland Security Committee ranking member Rep. Bennie Thompson (D-Miss.), a black lawmaker who has been outspoken about calling the Charleston shooting an act of domestic terrorism — a term Haley has also used to describe the attack — jumped at the chance to point out a contradiction in her logic.

The Confederate battle flag will continue to fly at The Citadel for the time being, after the rejection of a defense budget amendment in the early morning hours on Thursday. South Carolina Gov. Nikki Haley, who was on Capitol Hill on Thursday to testify at a hearing about the potential transfer of Guantanamo detainees to the Naval Brig in Charleston, said the state did not need Congress to interfere in the controversial debate. "They could very easily move the Confederate flag to the museum, which is right next door to where it's being housed now," Haley told reporters. "But they would have to do that through the same ways that we did it at the statehouse. As South Carolinians we handled that ourselves in South Carolina, so I don't think we need to go through a D.C. plan to do that, I think that's a matter of South Carolinians making that decision."

Note: Haley said that the process should go through the state legislature, which would have to make an exception for the college due to a S.C. state law called the Heritage Act. "What I told the cadets is that if this is a concern they need to contact their legislators, they would need to open the Heritage Act just for that specific facility and handle it accordingly, but right now we haven't seen any action," she said.

Associated Press: Senate passes \$40M aid bill for flood-devastated farmers

The Senate has approved a bill providing \$40 million to South Carolina farmers devastated by last fall's flooding. Senators voted 33-3 Thursday on legislation allowing farmers in disaster-declared counties to apply for up to \$100,000 in grants covering up to 20 percent of crop losses. The amended bill returns to the House, which passed its version 95-6. Agriculture officials say October's torrential rains wiped out \$330 million worth of crops at harvest time. Farmers lost an additional \$45 million because they couldn't plant winter crops in bogs. Supporters say the bill aims to help family farms survive until the next harvest.

Note: Gov. Nikki Haley has threatened to veto the bill, saying while she feels badly for farmers, she feels badly for small businesses too, and farmers shouldn't be treated differently.

South Carolina's Senate passed a bill that would grant relief for farmers affected by October's floods, setting up the chance of a veto showdown with Gov. Nikki Haley. The bill, which sets aside \$40 million for relief, would allow farmers to apply for a grant on a first-come, first-served basis for up to \$100,000 to pay for production expenses, such as seeds and fertilizer.

Note: "We're going to keep cheering and supporting the farmers in every way that we can to help them get back on track," Haley said. "I don't think we should treat them any differently than we do everybody else." Despite Haley's threat, both chambers passed the bill with a large majority, making a veto override by the

General Assembly likely. A request for comment from Haley's office was not immediately returned.

Opponents of legislation that requires refugees in South Carolina to register and holds liable those who help them resettle are asking a House panel to block the bill. Ministers, volunteers and college students said Thursday the bill discourages churches from their Christian mission of helping people while targeting people who are fleeing persecution at home. Noor Amiri told the panel he'd be dead if not for the federal refugee program. The Kabul, Afghanistan, native worked alongside U.S. Army soldiers for six years as their interpreter before coming to South Carolina in 2014. He pleaded with legislators not to "punish the people who need protection the most." The panel postponed voting on the bill. The Senate passed it last month. All two dozen people who testified opposed the bill.

Lawmakers amended the bill to make it so that civil legal liability is only applied for a sponsor if the group knew, or should have known, a refugee resettled through their organization posed a threat and committed an act of terrorism or a violent crime. To be held liable, there would have to be clear and convincing evidence presented in court. Smith said he appreciated the effort by subcommittee members to make the bill more palatable, but still opposed it overall. "When you build upon a pile of garbage, you've still got a pile of garbage," he said. "There's no way to fix it when it's foundation is a load of crap." Previously the bill did not call for the high standard to prove civil liability.

A state Senate bill that would have let Century Aluminum buy all of its electricity on the open market failed to get past a subcommittee hearing Thursday, dimming the possibility of a last-minute deal to save the company's Mount Holly smelter and its 300 jobs. "I never want to definitively say something is dead, because as long as we're in session there's always a possibility," said state Sen. Larry Grooms, R-Charleston and one of the bill's sponsors. "But I don't see a reasonable possibility at this point." Grooms said the bill, introduced earlier this month, got a late start in the legislative session and was gaining support but ran out of time.

Caitlyn Jenner has taken up Donald Trump's offer and used the women's restroom at one of his luxury buildings. The Republican presidential candidate said last week that he believes transgender people should be able to use whichever bathroom they choose. Trump said North Carolina's so-called "bathroom law," which directs transgender people to use the bathroom that matches the gender on their birth certificates, has caused unnecessary strife. Trump said that if Jenner — who won an Olympic gold medal as Bruce Jenner — were to walk into Trump Tower, she could use whichever bathroom she wanted. Instead, Jenner used the women's room — without incident — at the Trump International Hotel and Tower in Manhattan.

Transgender people in Oxford, Alabama, could now face six months in jail for using restrooms labeled for the gender with which they identify. The Oxford City Council passed the ordinance this week after the retail giant Target announced it would allow transgender employees and customers to use the restrooms they feel comfortable with. In the ordinance, the Council says people in public restrooms "do not reasonably expect to be exposed to individuals of the opposite sex while utilizing those facilities."

Republicans closely involved in gubernatorial races are advising governors — who might be pushed to consider similar bills or asked about the law by reporters — to keep precise wording and perception in mind. They believe the broadly written bill in North Carolina created a PR nightmare for the governor, one that's made it more difficult for him to explain his position to voters. "If there's an appetite in the state, something we've been advising is that perception needs to be on par with the wording," said one such Republican granted anonymity to speak candidly about strategy in dealing with transgender-bathroom bills. Governors, especially those who have difficult re-election battles ahead — whether it's this cycle or next — are being advised to distance themselves from the issue entirely.

Big changes are coming to the agency that helps get loans for massive road projects in South Carolina. The South Carolina Transportation Infrastructure Bank leverages money for \$100 million-plus highway projects. But the bank has come under increasing criticism over the past several years from environmental groups, conservatives, government reform activists and rural interests. The bank is criticized for not having firm guidelines for how its seven-member board makes decisions and chooses projects. Some critics say the bank chooses less needed new road projects instead of spending money on improving current highways. Environmentalists said those new projects often hurt wetlands and other protected areas. Other critics said the bank spends most of its money in only a handful of urban counties because it requires contributions from local governments.

This week, April 24-30, is National Re-entry Week, where we bring focus to the issues of returning ex-offenders into our communities and to the steps we've taken to reduce the rate of people returning to prison. An important part of the release process is preparing individuals to re-enter society and reducing the likelihood that they will return. In South Carolina, nearly 90 percent of offenders are released from prison in

five years or less. The state has a choice to make: prepare offenders for successful re-entry or continue the generational cycle of incarceration. We have chosen to provide inmates with opportunities for education, skills training and work experience as part of a pre-release program, a leading factor in reducing the recidivism rate, which is nearly 25 percent in South Carolina.

South Carolina is being called the country's fifth most dangerous state for drunk driving. A report released by CarInsuranceComparison.com ranks states using data provided by several agencies and organizations including Mothers Against Drunk Driving, the National Highway Traffic Safety Administration and the FBI.

"The people of South Carolina seem to be chugging more than just sweet tea," the report states. It says South Carolina ranks number three in the country for alcohol-related driving fatalities and finds that while DUI penalties are hefty, there are few laws combating drivers under the influence. No neighboring states made the top ten list, which ranks North Dakota as the most dangerous state, placing first in both fatality rate and DUI arrests.

A wave of airstrikes and shelling killed more than 60 people in less than 24 hours in the northern Syrian city of Aleppo, monitors and activists said Thursday. The contested city is now one of the main battlegrounds of Syria's devastating civil war, with a cease-fire that has collapsed and peace talks in Geneva stalled. At least 27 people died as a hospital supported by Doctors Without Borders and the International Committee for the Red Cross and nearby buildings were hit overnight in the rebel-held part of Aleppo. The U.N. envoy for Syria appealed early Thursday to the United States and Russia to help revive the peace talks and a cease-fire, which he said "hangs by a thread."
