---

TRIA discussions have commenced in Congress in early May. The Senate introduced and is preparing for a final mark-up of S2224 very soon. The House is looking at a different version but is expected to have a bill mark-up as early as **June 23**. PCI has received assurances from Speaker Boehner that TRIA will be reauthorized. The Senate is expected to have an 80 vote count.

PCI is working with industry partners, the NGA, RGA, and DGA to galvanize support regarding this matter. The DGA produced a study basically concluding that TRIA reauthorization is necessary. The NGA is preparing to act as well.

We are requesting targeted governors to support sending a letter to their Congressional delegation to support reauthorization of the Act. Additionally, we are also requesting state legislatures to pass resolutions regarding the same. Below is a full update as to the support that PCI is receiving around the country.
