- (1) Number of refugees that have come into South Carolina over the last 3 years (5 if we have it)
- (2) Which countries they are from
- (3) What reasons those refugees fled those countries
- (4) Facts on SC's 2 refugee programs and DSS' role
- (5) What those programs do for refugees
- (6) Why types of accountability measures are in place to know what services are provided, whether they have jobs, any other accountability data?
- (7) Description of the vetting process done by the State Department
- (8) Criteria used by State Dept to accept a refugee
- (9) Are there limitations that a state can place on the number of refugees that may come to a state
- (10) Will states be notified prior to when refugees are placed; if so, how much notice do we get

I know y'all already have many of the answers to these questions. Let me know if you think you can't get this info by Friday.

Spoke with State Department this morning. Specific to the 15,000 increase, they do not know where those individuals will be placed or what countries they will come from. Those are just approved slots for refugees that make the cut in FY16. Placement decisions don't happen until after the refugee has passed screening and been approved by DHS for entry. In the meantime, State is going to send over some background information on the screening process, and on the specifics of how resettlement functions in states without a State's involvement (i.e., if a state decides not to submit a state plan).

Same – we have not been contacted by State or the Federal Delegation regarding this announcement to increase US acceptance of refugees.

In terms of position –

The Governor's position on this issue is clear – our nation's role in international humanitarian aid is integral to maintaining our national security, promoting international commerce, and maintaining our moral obligation to aid those persecuted for religious or ethnic reasons. However, her first priority as Governor is the safety of our citizens and communities which is why she is so disappointed that the Obama Administration had not yet contacted her office to discuss South Carolina's role in this expanded refugee effort. Further, they have offered no assurances that the vetting process will remain effective under this expanded effort. Such assurances must be given to states if they are to be expected to further open our schools and homes to additional arrivals.

I saw over the weekend that Secretary of State John Kerry said the US would increase the number of refugees it accepts next year – from 70,000 to 85,000 – and some of them would be Syrian.
