DEAR MR. STIRLING,

THIS LETTER IS TO NOTIFY YOU THAT I HAVE TRIED IN NUMEROUS WAYS TO RESOLVE THIS PROBLEM WITH YOUR STAFF. THEY DON'T HAVE A CLUE AS TO WHAT VIOLENT OR NON-VIOLENT IS, WHAT YEAR THE CRIME WAS DEEMED VIOLENT AND MADE LAW. THEY CERTAINLY DO NOT KNOW ANYTHING OF S.C. CODE OF LAW 16-1-60, "VIOLENT CRIMES DEFINED". THEY DO NOT KNOW WHEN AN OLD CONVICT SUCH AS MYSELF COMMITTED A VIOLENT OR NON-VIOLENT CRIME. WHAT YOUR STAFF DOES KNOW IS HOW NOT TO KNOW THE LAW IN QUESTION.

PLEASE PAY ATTENTION MR. STIRLING? I WAS ARRESTED NOVEMBER 18, 1993 IN HORRY COUNTY. SERVED WITH ONE ARREST WARRANT. YOU HAVE THIS IN YOUR FILE. BURGLARY 2ND DEGREE, VIOLENT INDICTMENT #: 94-GS-26-1394. THIS CHARGE IS NOT IN QUESTION AT THE MOMENT.

H 4365 GENERAL BILL, BY WILKINS, ALISON, L.L. ELLIOTT, HARRELL AND VAUGHN

A BILL TO AMEND SECTION 16-1-60, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO VIOLENT CRIMES, SO AS TO REPEAL THE PROVISIONS REQUIRING THE CRIME TO BE DEFINED AS A VIOLENT CRIME AT THE TIME IT WAS COMMITTED.

THE DATES OF THESE CRIMES ARE THE REASON THEY ARE NON-VIOLENT.

SECTION (B) OF S.C. CODE 16-1-60.
FOR A PERSON TO BE CONSIDERED GUILTY OF A VIOLENT CRIME, THE OFFENSE MUST BE DEFINED AS A VIOLENT CRIME PURSUANT TO SUBSECTION (A) AT THE TIME OF THE COMMISSION OF THE CRIME.

THE DATES OF THE CRIMES ARE LISTED ON THE ARREST WARRANTS AND THERE IS NO MISTAKE IN THAT. THERE IS NO MISTAKE IN THE DATE THAT I WAS ARRESTED.

THESE CRIMES HAVE ALWAYS BEEN CLASSIFIED AS NON-VIOLENT UNTIL APRIL 22, 2015, WHEN I RETURNED TO SCDC ON A PAROLE VIOLATION. YOUR PEOPLE "LILA ROBERSON, ANALYST III, INMATE RECORDS", RE-CONVICTED ME AND RE-SENTENCED ME. THESE WARRANTS WERE SERVED ON ME NOVEMBER 22, 1993. I AM NON-VIOLENT

LILA ROBERSON, INMATE RECORDS, ANALYST III HAS ALSO CONTACTED THE PAROLE BOARD AND TOLD THEM TO UPDATE THEIR RECORDS THAT I AM VIOLENT IF YOU ASK HER AND SHE DENIES IT, I HAVE THE LETTER AND ALSO, R. SALTSBURG, ACTING CASE MANAGER HERE AT McCORMICK, HAS A COPY ALSO.

I'M GOING TO TAKE LEGAL ACTION AGAINST YOU, SCDC, AND LILA ROBERSON, INMATE RECORDS ANALYST III. MR. STIRLING, PLEASE EDUCATE YOUR PEOPLE! CAN YOU IMAGINE HOW MANY INMATES HAVE THEIR RECORD SCREWED UP BY AN INCOMPETENT SCDC STAFF MEMBER?
