It was nice speaking with you earlier today. As promised, attached are some helpful documents reviewing and explaining Florida's K-3 Literacy/Ending Social Promotion policies. Attached are a one-pager on the policy; an expanded white paper and the results Florida has experience in the wake of the policy; and model legislation (which is different and improved from Florida's, since we had to learn some things the hard way and amend our laws later on!)

Also, I'd like to tell you what services we can offer at no cost to you:

- In person or online presentations explaining and detailing any of Florida's reform policies. Pioneered in Florida were A-F school grading and our highly successful, clear and easy-to-understand student-achievement based grading formula that complies with federal waiver requirements; as well as our K-3 Literacy policies, including our hard line in the sand on third grade retention.

- We can review any draft legislation and provide commentary and feedback.

- We can offer expert testimony in committee or before any executive boards/task forces at the invitation of a legislator, superintendent or the governor.
