Happy New Year! I want to personally thank you for the additional HCBS funds. As we discussed \$42,032 will be used to keep Greater Faith and Joy open through June 30, 2013. I am also contacting my contractors to determine their needs for the additional HCBS funds identified on the NGA. I do have one

question. When I initially sent you the request to keep Greater Faith open (see attached) it stated that in order to keep the site open \$16,203 was needed in Group Dining and \$29,703 was needed in transportation for a total of \$45,906. The additional funds on the NGA are identified as HCBS. When I reviewed the current policy and procedure manual SECTION 600, Page 1. It states that HCBS (State General Revenue) is to be used for :

Adult day care;

- case management;
- chore maintenance;
- group dining;
- home delivered meals;
- home safety assessments;
- homemaker;
- housekeeping;
- medication management;
- minor home repairs; and

- any service approved through the Area Plan process.

It does not specifically state that transportation, but it does state any service approved through the Area Plan process. How would you like for me to handle this? I can submit an addendum to the Area Plan or get your offices approval via this email. Please advise.
