A regular meeting of County Council of Charleston County was held on the 10<sup>th</sup> day of January, 2012 immediately following the special Finance Committee meeting, which was held in the Beverly T. Craven Council Chambers, Second Floor of the Lonnie Hamilton, III Public Services Building, located at 4045 Bridge View Drive, Charleston, South Carolina.

Present at the meeting were the following members of Council: Teddie E. Pryor, Sr., Chairman, who presided; Colleen Condon; Henry E. Darby; Anna B. Johnson; Joseph K. Qualey; A. Victor Rawl; Herbert R. Sass, III; Dickie Schweers and J. Elliott Summey.

Also present were: Allen O'Neal, County Administrator and County Attorney Joseph Dawson.

The Clerk reported that in compliance with the Freedom of Information Act, notice of meetings and agendas were furnished to all news media and persons requesting notification.

A report was read from the Finance Committee meeting of January 5, 2012 that it considered the request of Council Member Henry Darby that Council approve a Resolution recognizing the contributions of Bernard Paul Chisolm to Charleston County's Workforce Development Minority and Business Enterprise and Organizational Development Efforts.

Committee recommended that Council approve the requested Resolution.

Mr. Darby moved approval of Committee recommendation, seconded by Ms. Johnson, and carried.

The Chairman asked Council Member Darby to read the Resolution and requested Mr. Chisolm and his family to come forward.

The Resolution is as follows:

**A RESOLUTION RECOGNIZING THE CONTRIBUTIONS OF BERNARD PAUL CHISOLM TO CHARLESTON COUNTY'S WORKFORCE DEVELOPMENT, MINORITY & BUSINESS ENTERPRISE, AND ORGANIZATIONAL DEVELOPMENT EFFORTS.**

**WHEREAS**, Bernard Chisolm has proven himself to be an invaluable employee of Charleston County; and

**WHEREAS**, Bernard Chisolm made a lasting contribution to the workers of Charleston Naval Shipyard as he managed their employment transition caused by the Base Realignment and Closure (BRAC); and

**WHEREAS**, Bernard Chisolm was instrumental in the development, implementation and management success of the State's first One Stop Career System; and

**WHEREAS**, Bernard Chisolm created, developed and implemented a number of specialized initiatives to include a nurse aide program that trained and placed over 300 individuals; and

**WHEREAS**, Bernard Chisolm's contributed efforts were key to the Trident One Stop Career System being named the best in the state and the nation; and

**WHEREAS**, Bernard Chisolm successfully introduced the WorkKeys Assessment Program to the Trident Community and to the State of South Carolina; and

**WHEREAS**, Bernard Chisolm designed, developed and established the County's "1 per Million" On the Job Training program, requiring that every contracted million dollars result in a training opportunity for County residents; and

**WHEREAS**, Bernard Chisolm contributed to the County's organizational development and growth by creating its Suggestion Program, and redesigning its County wide Performance Management system.

**WHEREAS**, Bernard Chisolm created the County's M/W/DBE policy and created and established the County's Local Resident Employment Program guidelines of which both are now included in all County construction solicitations and bids resulting in employment opportunities for County residents; and

Charleston County Council recognizes and appreciates the outstanding contributions of Bernard Paul Chisolm to the advancement and growth of Charleston County and to its citizens.
