Planned Parenthood - *Appalling*

Dear Friends:

The South Carolina General Assembly is out of session until January. That doesn't mean our legislative work stops. To the contrary, legislators continue to address constituent needs, prepare legislation and attend committee hearings addressing critical issues. Here are a few highlights of what's happening.

Planned Parenthood Under Scrutiny

I'm one of twenty-six House Republicans who has signed a letter asking the Legislative Audit Council to review any taxpayer money provided to Planned Parenthood's clinics in Columbia and Charleston. We requested the audit of Planned Parenthood clinics while Congress considers cutting off federal funding to the abortion provider.

The financial scrutiny follows the release of videos, secretly taped by the anti-abortion group Center for Medical Progress, showing Planned Parenthood officials elsewhere discussing the collection of fetal organs for research. In my view, the bodies of aborted, unborn children should not be sold or harvested for any purpose, including scientific research. What we have all seen in those videos is appalling.

The House Legislative Oversight Committee, on which I serve, will likely hold public hearings on Planned Parenthood funding. This new committee is the investigative arm of the House of Representatives and is meeting this week to decide if it will probe Planned Parenthood and other organizations that receive public funding to determine if taxpayer's funds are supporting the harvesting of baby body parts.

The Oversight of S.C.'s Colleges and Universities

Beginning in mid-September a special House Committee will begin examining governance structures

for higher education around the nation to determine the best coordinating structure to oversee South Carolina's thirty-three public colleges and universities. I chair the ad-hoc committee.

At the center of our consideration is proposed legislation, H.3249, which calls for the creation of a Board of Regents, similar to those in Georgia and other states. We will also be examining the coordinating structure currently in place in South Carolina.

At the first session we will hear from national experts in the field of Higher Education governance structure. At subsequent hearings we will hear from the South Carolina Commission on Higher Education, the SC Technical College System, the Presidents of our state universities and colleges, as well as others.
