Good afternoon Rob Godfrey,

We are contacting you to kindly ask you to participate in a research study because of your role as Deputy Chief of Staff (Communications and External Affairs) at the Office of the Governor Haley.

We selected you because your Office took a very active and relevant role in communicating during the massive flood that affected Columbia and several regions of South Carolina in October 2015, using social media in order

to convey information to publics and interact with mass media.

This study is conducted by Dr. Alessandro Lovari, visiting scholar at University of South Carolina and Dr. Shannon A. Bowen, Professor, University of South Carolina. It is a private, non-funded research study in which we will keep your personal name and identifying factors confidential, but we would report the main insights at a PR conference in early March and in a journal publication (such as *the Journal of Public Affairs* or other PR journals).

The purpose of this research is to understand the role of social media during emergency management and disaster relief. In particular, this study focuses on the role of Twitter and other social media as used by government official and public sector agencies and organizations as part of a crisis management communication activity.

We would need only twenty minutes of your precious time for an in-depth interview that will be conducted among state officials and communication or public relations specialists in order to advance our understanding of strategic social media use for emergency management. The interview will be conducted in person, by telephone, or using a VoIP service, such as Skype, and it would be scheduled at your convenience. The confidential interviews will be audio-recorded and transcribed to assist with data analysis, in accordance with the highest ethical standards for the protection of human subjects.
