My name is Hannah Tucker and I reside in Laurens County, SC. I am writing to you in regards of some criminal charges I was arrested for recently along with some certain things about an individual in the Laurens DSS system that I have some major concerns about by doing people wrong. I really hope and pray you will find it in your heart to read this whole letter and help and innocent person. I am going to explain the charges and what happened before I adress anything else because they all stem together.

I am a shift manager at the Dollar General in Joanna, SC. They have me out on FMLA right now because of everything going on. I have two children ages 2 and 5, and a stepdaughter that my husband and I were about to receive full custody of at the age of 4. While working in Joanna I met some new people that I thought were friends.

On Oct 7th, 2015, I had an individual Donna Miller come to my home with the intentions of staying the night. She was supposed to be babysitting for me the next morning because I had to be at work early. She called me and told me she was there but I wasn't. I told her to go on in and me and the girls would be there shortly. After I got home, I got my kids in bed, spoke with Donna a few minutes and then went to bed myself. My daughter come running in my room about an hour after in bed screaming the cops were there. I went and opened the door and apparently they heard that someone was wanted was in my home, so I let them come in and look for this person to prove he wasn't there. In the meantime, they started going through things that were in my kitchen. Donna had 3 or 4 bags (1 being a suitcase) lined up against my kitchen wall and she told me she was washing clothes. When the cops started going through it they found a meth lab in the middle of being cooked. It was all sealed which is why I didn't smell something funny. We both went to jail. One of my kids is with my grandma and the other is with her father. He got a private lawyer outside of DSS. My stepdaughter I have been fighting for custody for and was about to win is not even allowed around me at this point.

After I got bailed out I obtained video proof I didn't know it was there, along with a couple of other things. I have the video,. Donna Millers phone that can be of use, and I would be willing to testify against her. They charged me with trafficking meth over 100 grams, 2 unlawful neglects of a child, and possession of adderall. (I did have my husband's adderall).

I have family courts hitting me from all angles. I would like to request your help in getting all this done and having it taken care of so I don't lose my babies over something I did not do if you can find it in yourself to help me.

From all this DSS is involved. The investigator in DSS, Mindy Bentley, has completely lied in her report along with giving confidential paperwork to my ex husband. I'm hearing of so many people that Mindy is doing wrong by. She stated I had a known meth cook in my home (which it was not known). She stated I had liquid meth in my purse to my family (which was an absolute lie, and caused my family to wonder). She's threatened me many times to send my baby to foster care if I don't cooperate, which I always cooperated and did a little to much to stay on top of things, which I don't think she liked. I spoke with a sergant that arrested me and he told me she couldn't do that if I had relatives willing to take my babies temporarily. She gave my perosnal and confidential drug screen along with my 2 year old daughters to my ex husband which he took into court (my ex husband is not her father). And lastly she put on my paperwork that I was also charged with possession of meth, which I was not. This is only my situation.


My sister Kristi Moubray open a case with DSS against her husband (they are separated) because she found out her husband's girlfriend's little girl was trying to sexually touch Kristi's daughter (my neice), and the girlfriend physically abusing my nephew. About 2 weeks after she opened it a DSS determination meeting was set up. Her husband (Daniel) knew of this meeting and was there. My sister, Kristi, had no knowledge of it until the meeting was already in pregress. Mindy Bentley put into my sister, Kristi's, report that her house was nasty and dirty and had no food. With this being said, Kristi tried MULTIPLE times to get Mindy to come to her house and look at it and to speak with her. Mindy Bentley has NEVER been to Kristi's house and falsely reported these statements.

I am asking that if you can make these things be investigated, please do. Along with helping an innocent person so I can bring my kids home. The law is taking so long to the point where I am about to lose my oldest and my step daughter. There are so many other things that I have heard about the DSS investigator, but these are the 2 that I have witnessed.

I would love you hear something back from you regarding this. Im also having my sister sign this so you know she is a witness to both of these as well. Thank you so much for taking the time to read this. My contact information is below.
