**CALL TO ORDER AND PRAYER**

Chairman J. Matthew Rivers welcomed everyone and Council Member Cole opened the meeting with prayer.

**ADOPTION OF AGENDA**

Council Member Curtis made a motion to adopt the January 11, 2012 meeting agenda with approved changes. Council Member Cole seconded the motion. Voting in favor of the motion was unanimous.

**ELECTION OF CHAIR AND VICE-CHAIR**

Council Member Bruce E. Rivers made a motion to nominate Council Member J. Matthew Rivers as chairman. Council Member Plyler seconded the motion. Voting in favor of the motion was unanimous.

## **APPOINTMENTS**

### **a. 2012 Sandblast Rally – Anders Green**

Mr. Anders Green appeared before Council seeking the approval of Council to run the annual 2012 Sandblast Rally on February 4, 2012. This event is run each year in Chesterfield County with the approval of Council to use certain County Roads. Mr. Tim Eubanks has inspected the roads and has been in contact with Mr. Green regarding any problems. Council Member Plyler made a motion to approve the use of the specified roads to run the annual 2012 Sandblast Rally. Council Member Curtis seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

### **b. Mr. Arthur Bays, Teal's Mill Bridge**

Mr. Bays appeared before Council to give them an update on the Teal's Mill Bridge. Mr. Bays advised that the bridge opened at 1:00 p.m. on December 29, 2011. He advised that the bridge has a 25 ton limit and it is very slippery when it gets wet. Mr. Bays also advised that no trucks with over 8 tires or any vehicle with over 8 tires can use the bridge, such as gasoline tankers, propane tankers, log trucks, etc. There is a detour for these type vehicles. Mr. Bays advised that the Sheriff and DOT is going to monitor this along with the people in the Teal's Mill community. He stated that they are going to take tag numbers and people would be fined a stiff fine for crossing the bridge in any type vehicle with over 8 tires. The speed limit is 25 mph across the bridge. The bridge is a metal deck bridge and it is very slick. If it snows or ices up the bridge will be shut down. Mr. Bays thanked all the people of Teal's Mill, Cheraw, Chesterfield, the Cheraw Fire Department, Teal's Mill Fire Department, EMS, Sheriff's Department, Tim Eubanks and the County Road Department and especially the DOT people that have worked hard on this bridge. He also thanked Senator Vincent Sheheen and Representative Ted Vick for their involvement.

Mr. Bays also made a statement that he attended the School Board Meeting regarding religion in schools and that he went to support this and he thought that all Christians should stand up for Christian rights in this county and all over the world and that he just wanted to make that statement to council.

### **c. Mr. Richard Lane Brown, III., Alco Representative**

Mr. Brown appeared before Council and presented Council with a handout that contained the background material for his presentation. Mr. Brown stated that it was a tax issue and that he felt they deserved a refund. Mr. Brown gave a presentation to Council in support of his claim, on behalf of Alco Stores for refund of tax penalties paid and stated that he hoped that Chesterfield County Council and its Finance Committee would favorably consider their request for refund, certainly of the penalties.

**PUBLIC COMMENTS**

**Karen Stangal, Paws & Claws Volunteer**

Ms. Stangal appeared before Council and stated that she thought the improvements at the Animal Shelter were extensive and that there was a good crew working at the shelter and she thought they were trying to do the best they can with the amount of animals that still come into the shelter. Ms. Stangal stated that she thought the workers were doing an exceptional job once the animals come in as far as record keeping, improvements, etc but that the intake side is still in some type of flux. She stated there doesn't seem to be a good working relationship and the county is 80+ days into this and that as an individual that goes to the shelter on weekends and goes over to the shelter when she is in Chesterfield, she stated she didn't see an improvement in that working relationship so she felt that is something that needs to be looked at. Ms. Stangal said she believed the shelter manager should be in control of everything, not just reacting as the animals come in but proactive on the end of what comes in and when they come in so that there is more of a control on the capacity level and the conditions of the animals as they come in. Ms. Stangal thanked everyone for everything they had done to improve the shelter but stated that this is another deficiency that she thought still exists and that it would be the County answering the deficiency problem as the inspections go on with the shelter from the Humane Society.
