SECTION 1: The Minutes for the meeting of July 22, 2004; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion approving the request of the Department to seek qualified firms to provide project management and construction engineering inspection services for the I-26/Aviation Avenue/Remount Road Improvement project in North Charleston, as shown in detail in the Appendix.

SECTION 3: The Commission unanimously passed a motion approving the request of the Department to advertise and select a firm for the purpose of providing engineering services for various bridges in the State, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion approving the request of the Department to advertise and select a consulting firm for the purpose of providing engineering services for the update of the SCDOT Seismic Design Specifications for Highway Bridges, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the action of the Department in removing roads from the State Highway System, as shown in detail in the Appendix.

SECTION 10: The Commission unanimously passed a motion revising the action of the Department concerning projects in the June 8, 2004 highway lettings as shown in detail in the Appendix.

Professional Services Recommendations

September 2, 2004

The following sheets include recommendations for the Department to utilize professional consulting firms to provide various services, which may include design, right of way acquisitions, construction engineering and inspection, or other associated services. The Department requests approval from the Commission to advertise, select and negotiate for these necessary services.

The South Carolina Department of Transportation (SCDOT) is seeking qualified firms to provide project management and construction engineering and inspection (CEI) services for the I-26/Aviation Avenue/Remount Road Improvement Project in North Charleston, SC. The project consists of the following major activities:

- Widening of approximately 3 miles of I-26 from 6 through lanes to 8 through lanes and rehabilitation of existing concrete pavement.
- Widening of two I-26 bridges over Midland Park Road and Southern RR.
- Reconstruction of I-26 interchange with Aviation Avenue to include complete replacement of bridge over I-26.
- Reconstruction of I-26 interchange with Remount Road to include complete replacement of bridge over I-26.
- Construction of east and westbound collector distributor systems.

REQUEST FOR PROFESSIONAL ENGINEERING SERVICES FOR:

BRIDGES IN VARIOUS COUNTIES

These projects will be funded through Bridge Replacement Program.

- 1] SC 28: Bridge over CSX Railroad in Abbeville County (3rd Congressional District)
- 2] S-1-32: Various Bridges Along S-1-32 in Abbeville County (3rd Congressional District)
- 3] S-34: Bridges over CSX Railroad and Wilson Creek in Newberry and Greenwood Counties (3rd & 5th Congressional Districts)
- 4] SC-9 Bridge over Lake Bowen and S-42-43 Bridge over Pacolet River in Spartanburg County (4th Congressional District)

The Department requests Commission approval to advertise and select a consulting firm or firms for the purpose of providing engineering services for the replacement of the above bridges. Based on current and projected workload, the Department does not have sufficient staff to proceed with these projects.

REQUEST FOR PROFESSIONAL ENGINEERING SERVICES FOR
UPDATING THE SCDOT SEISMIC DESIGN SPECIFICATIONS FOR HIGHWAY
BRIDGES

The Department requests Commission approval to advertise and select a consulting firm for the purpose of providing engineering services for the update of the SCDOT Seismic Design Specifications for Highway Bridges. The Department currently uses the first edition of the Specifications, 2001, including interims, and Bridge Design Memoranda to complement and amend the Specifications. The Departments desires to update these Specifications to reflect the latest seismic hazard practice, to reflect findings during the implementation stage of the Specifications, and to include the work of the South Carolina Seismic Hazard Maps research project. Based on the current and projected workloads, the Department does not have sufficient staff to prepare the updated specifications. This project will be funded through the Federal Bridge Replacement Program.

Removal of Roads From State Highway Secondary System

September 2, 2004

The Department recommends Commission approval for the removal of certain sections of secondary roads from the State Highway Secondary System. These sections of roads may be removed for one of the following reasons:

1. Abandonment of Relocated Section of Highway
2. Deletions and Removal of Roads from State Secondary System - Roads may be deleted and removed from secondary system by exchanging for equal or less mileage or roads, which have a higher traffic importance. Ownership reverts to local government having jurisdiction (city or county). Approval of deletion or removal by local government is not required.
3. Abandonment of Right-of-way - Right-of-way may be abandoned if it is determined that the right-of-way is not required for right-of-way proposes or if the right-of-way is not needed for Department purposes.
4. Court Order
