Dear Mr. Belser:

Thank you for your request of July 17, 2013. Our procurement contracts are often complex, being composed of multiple documents, not all of which are retained by the agency. The contract for brokerage services for non-emergency medical transportation was originally let by the Materials Management Office (MMO) of the Budget and Control Board. The original (incorporated) solicitation for the contract can be found on the State Procurement website at <http://webprod.cio.sc.gov/SCSolicitationWeb/contractsSearch.do?solicitationnumber=5400002201>.

Included on the disc, is the redacted (incorporated) proposal for region 1. The contract for region 1, then, is comprised of the solicitation with all amendments, the proposal, and the Change Order which is also found on the disc. Regions 2 & 3 are under an emergency contract, which is on the disc along with its amendments. You will note that the emergency contract references the original solicitation documents, found at the link provided above, and proposals. MMO retains the redacted proposals submitted by LogistiCare for regions 2 & 3.

As mentioned, some of these documents have been redacted in accordance with the desire of the submitters to protect data or processes. Under S.C. Code Ann. §30-4-40(a)(1) and §11-35-410, we try to honor the submitters' designations of information they consider proprietary. The redacted information is apparent in the documents.
