## Description of the Incident

In fact, two days after its appearance on the web, Steve Ballmer resigned from his position as CEO of Microsoft. It was a huge change obtained after 24 years of a more than insane harassment which used the means of states, at least France and America, but also Israel, China, India, Russia, if I think to MH17...the means of corporations, of the movie industry, the media...I surely forget some, for the number of persons and organisations involved in it is terrific. It was decided and organised by the Rothschilds against both Bill Gates and I, immediately after he went to me with Michel Lacombe at a professional event in Paris, Acquaboulevard, June 12, 1990. He did not even speak to me, I did not see them, left before they arrived to me. The only fact that he publicly showed an interest on a non Jewish woman had consequences for 24 years.

I already filed more than 200 complaints behind the FBI. Began December 31, 2013, as Microsoft search of CEO was still active. I had sent many emails to its executives and shareholders, to professionals in Seattle. If they did not answer me, they opposed nothing, and finally Microsoft recognized the harassment in a letter it sent me August 5, written August 4. It was a trap. As I complain, the control of the ones in the know looses its efficiency and both Bill Gates and I faced hearings in the aim to obtain that one accused the other one of having harassed him. That way, it would have been a crazy story between two insane personalities. Except that it would not explain why Steve Ballmer resigned after my note was published. I faced this hearing August 7, had received Microsoft letter August 6, Bill Gates faced repeatedly the Judge Fred Bonner and the Sheriff Dow Constantine during December 2014. They presented him and his children, both Steve and Connie Ballmer as well as Melinda Gates being present and active, false testimonies asked and obtained against me. Some were done by my four brother and sisters with whom I have no relations since 1997. Some by professionals such as Robert Hare and Paul Babiak against whom I complained, writings which seem to have been asked by Satya Nadella.

The harassment involved events which concern the whole world, such as 9/11 and the wars which followed, MH370 and the two nuclear false flags it hide, which did not occur for Philip Wood, the IBM employee present aboard and supposed to be presented as the ill brain responsible, sent a message March 18 on archive4, exposing he was prisoner, joined a pic whose exif indicated Diego Garcia. He stopped a plot sold to embassies as a revenge plot with false actors. If prisoner, he was a true passenger, and the revenge plot hide false flags.

Such a scenario requires expertise. It is obviously insane, and it requires expertise. Charlie hebdo, which also seems to be a Rothschild plot, requires expertise and to observe what it allowed exposes the cui bono for a huge emotional movement occurred and the attack was linked to 9/11, presented as the french 9/11. A move as the one orchestrated after Charlie hebdo attack, aims to erase this knowledge. It requires a huge expertise observed immediately when we think it can have been a false flag. As soon as this possibility is evoked, the premeditation appears obvious, the calculation very precise.

As I exposed it in former complaints, I faced years of confusion. I knew I was targeted by persons using a network and having connections in each sector of live. It took me years to understand that two persons/groups were active, one fighting the other one. Things occurred in real life and on my computer. I

finally succeeded in being helped by the connection related to Bill Gates and received many informations that way. I exposed them on blogs I had until December 24. That day, after I sent widely three complaints I completed in which I described the plot Bill Gates faced as he was asked to accuse me, over-blog closed the three blogs I had on their plateform. They immediately deleted all my data, though the first one <http://www.les-attentats-du-11-septembre-vus-par-une-conspirationniste.com/> was active since November 2008. Its whois is inaccurate and prevents me from transferring it. Its status is clientTransferProhibited and Gandi, its registrar refused repeatedly to indicate my email adress and to change the status, pretending it would be owned by Over-Blog. This exposes the intensity of the fight and the struggles of power active.

To file complaints and to expose them in blogs led me to an understanding which would have been impossible to reach otherwise. I opened August 28 a new website decided to present the complaints in it. I chose the url <http://911-a-rothschild-coup-using-microsoft.com>, which appeared validated by the persons active behind my computer. Immediately a picture appeared proposed in the header with the logo of the FBI-IC3 presented twice, an animated picture. The website was active three weeks, abusively closed with a false pretext and I was sent a lawyer Cyril Fabre, who works with Raphael Picot d-Aligny d-Assignies: <http://www.landwell.fr/la-9eme-journee-de-formations-juridiques-propriete-intellectuelle-et-numerique.html>

I immediately thought back to another Picot d-Aligny d-Assignies, Hubert, to whom I was sent by Jacques-Antoine Malarewicz in 1999. At the time, I really needed help. I had been ill during years and the diagnosis was difficult. I had tuberculosis, but only in the lymph. I was cured and wanted to study and work again. I was not helped at all. Remembered Jacques-Antoine Malarewicz even more than Hubert Picot d-Aligny d-Assignies. In fact, later, as I exposed with details and proofs what happened to me to a doctor who knew him, she was certain of the involvement of Bill Gates. I asked her why, wondered on the possibility I fail, and told her that Jacques-Antoine Malarewicz once told me I though I was the center of the world. She appeared angry as we are when we receive two opposite explanations and asked me to go back to him and then tell her what he would have said.

Arielle de Rothschild wrote with Jacques-Antoine Malarewicz among other ones Et la confiance, bordel? She married Edouard de Rothschild in 1991. I face a network which has connections everywhere, try to identify them one by one, and went to the conclusion that Malarewicz has the expertise required by numerous attacks done in the context of the harassment done, from 9/11 to Charlie hebdo attack. I filed a complaint against him, sent it widely and added him in the receivers. He did not say a word. My complaint is: I1501141810228982. I filed it two days ago, and was surprised by the intensity of the signs appearing on my computer, asking for mails to be sent. I followed the indications, suppose I am again targeted, for the aim is to avoid the responsibility for crimes committed since 1990. Malarewicz has all the abilities required but acted hidden behind a very respectable appearance. As soon as I send mails presenting him as the evil mind who conceived 9/11, it is obvious that I shall be targeted, presented as insane. It changes nothing to the fact that my blogs were closed December 24, immediately after I sent my three complaints against Barack Obama, Melinda Gates, Fred Bonner. To close so brutally a blog opened for 6 years and to do it so illegally cannot be done without precise reasons. I exposed this close in many complaints, some against Marc Ladret de Lacharriere and Veronique Morali who bought Over-Blog, and controlled it that way April 2014, soon after MH370 plot failed. The plane is always in Diego Garcia. The Rothschilds helped by Malarewicz use all their network to avoid the law, as they did for more than two centuries. They disqualify Bill Gates by this insane video imposed to him, the water issued of human feces. They obtained false testimonies against me which cannot even be plausible, done in a context of harassment clearly exposed and recognized by Microsoft. The aim is to find a bias to silence me, what was begun by the close of my blogs. I met the difficulties evoked with google who appeared acting to prevent me from receiving the mails from IC3 what is only possible on Explorer in a mail box never opened on firefox or chrome. As soon as I need to reboot, I cannot anymore access to it. Have to open another one. The fight is intense, the issue concerns the whole off us for this criminal network which acted hidden for more than 200 years is determined to impose a jewish dictatorship on the planet, reason why it controls completely the internet,

and uses deception at such a level it uses Dieudonne as their agent, since he appeared in his show on the TV. It was pure calculation and he tells the truth when he presents Manule Valls as his agent. One pushes for the other one, with different aims, different means. The result is identical, deception, treachery. Signed Rothschild.
