Mr. Poore called the meeting to order and Reverend W. P. Atkinson gave the invocation.

On the motion of Mr. Rhodes, seconded by Mr. Wright, Council voted unanimously to have the minutes of the March 10, 1977 meeting read by the Clerk to Council. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to approve the minutes as read.

Mr. Hehn discussed a proposed agreement with Smith Data Processing. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to receive the proposed agreement as information.

On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to adopt Ordinance Number 14, Purchasing Rules and Regulations, on third and final reading.

Mr. Clinton King, Director of the Anderson County Solid Waste Authority, requested \$389,120.94 for the Solid Waste Authority during the 1977-78 fiscal year. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to receive the Solid Waste Authority's budget request as information.

Mr. Jimmy Burdette requested \$293,845 for the Clerk of Court offices during the 1977-78 fiscal year. On the motion of Mr. Gerrard, seconded by Mr. Bratcher, Council voted unanimously to accept the Clerk of Court's budget request as information.

Mr. Bruce Fradrich, a Clemson University student, requested permission from the Supervisor and members of Council to perform tests on Slash Pines which are on County property near the intersection of U.S. 76 and S.C. 252. On the motion of Mr. Gerrard, seconded by Mr. Rhodes, Council voted unanimously to permit Mr. Fradrich perform the tests.

Mr. Poore stated that the ice machine at the County Jail is out of order. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to request Mr. Hehn check into the matter.

Council approved bills for the month of February, 1977.

Mr. Poore stated that bids on six (6) conventional dump trucks and three (3) patrol cars will be opened on March 16, 1977 at 11:00 a.m. in the Supervisor's Office. Mr. Poore invited members of Council to attend the bid opening if they desired.

On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to adjourn at 8:30 p.m.
