### Governor Nikki Haley News:

**TIME:** South Carolina Governor Recognized for Handling of Charleston Shooting

South Carolina Gov. Nikki Haley will receive an award from the Harvard Foundation for Intercultural and Race Relations Thursday in recognition for leadership after this year's Charleston shooting, her office said.

**Note:** Haley, who orchestrated the effort to remove the Confederate Battle Flag from the state capital grounds days after nine worshipers were killed at the Emanuel AME church, will deliver remarks about what the country can learn from South Carolina and its response to the shooting, her spokesman, Rob Godfrey, told TIME. She will also meet with students at the university's center for public service.

Medicaid paid for 222 abortions in South Carolina over the past five fiscal years, but none of those were provided by Planned Parenthood, the agency's director said Wednesday to legislators who are investigating state spending on abortions. South Carolina's Medicaid agency has spent \$437,361 on 222 abortions performed between July 1, 2010, and July 30, 2015.

**Note:** As a result of an investigation requested by Gov. Nikki Haley, the state Department of Health and Environmental Control suspended the licenses of two of the state's three abortion clinics earlier this month.

South Carolina's Medicaid agency has paid for 222 abortions during the past five years, according to a state agency. Planned Parenthood could have performed up to two additional abortions, a S.C. House oversight panel looking into how state agencies interact with Planned Parenthood was told Wednesday.

**Note:** Reed said the investigations of Planned Parenthood, requested by Gov. Nikki Haley and S.C. legislators, "were motivated by the political witch hunts that have been going on across the nation."

About 222 South Carolina women received abortions paid for by Medicaid over the past five years, though none of those occurred at Planned Parenthood's Columbia clinic, a state official says. The information surfaced during a three-hour hearing Wednesday by a state House oversight committee examining whether Planned Parenthood or other abortion providers receive state funds.

**Note:** GOP Gov. Nikki Haley ordered inspections by DHEC of South Carolina's three abortion clinics in August, which found dozens of violations and resulted in orders of suspension for the Greenville Women's Clinic and Planned Parenthood's Columbia Clinic.

**WCIV:** Poll: Two-thirds in SC support removal of Confederate Flag

Two-thirds of South Carolinians surveyed in the latest Winthrop Poll thought state lawmakers made the right decision to remove the Confederate Flag from Statehouse grounds. The newest poll from the university shows that by race, 54 percent of whites and 93 percent of blacks thought the flag's removal was the right decision.

**Note:** Gov. Nikki Haley, who pushed lawmakers to act in the wake of the Emanuel AME shooting and remove the Confederate Flag, has an approval rating of 55 percent, which is essentially unchanged since March.

The College of Charleston must make spending cuts this year to deal with a \$1.5 million budget shortfall, according to a college spokesman. School leaders have not yet decided where they will trim spending, but they do know the reason for the shortage: Not enough out-of-state students enrolled this year, meaning that the college is missing out on revenue from those students' higher tuition rates.
