RE: The Introduction of the Federated United African States [UAS] and the UAS' Trade, Commerce, Economic & Industry; for the North American Region and Its President, Mr. Victor O. Obasuyi

In furtherance to my Administration's desire to inform, seek and find support; to promote geopolitical collaboration of socioeconomics alliance of the Federated United African States [UAS] with the Federal United States of America, on one hand, and with State of Alabama on other, I hereby introduce Hon. Victor O. Obasuyi to you as the UAS' North American [USA, CANADA & MEXICO] Region as the President of Trade, Economic, Commerce and Industry [TECI].

**THE FEDERATED UNITED AFRICAN STATES:** The Federated United African States [UAS] was declared January 31, 2010 in Addis Ababa Ethiopia; by the Constitutive Heads of State and Government Leaders during the African Union's Summit. Obasuyi, is the President in full charge, with mandate, audacity and authority to act and sign any approved agreement with anybody, state government(s) or organization(s) by acting in the best interest of the UAS; within the entire 'North American Region' for UAS in trade, commerce, Economic, Engineering, Industries Agriculture, Construction and Industrial Development; to act for the implementation and execution at all levels of any African Continental Tolls [ACTS] Infrastructures Development 100 Years' Master Plan and the New Nigeria's infrastructures Development 10 Years' Master Plan. You will notice from the website, that the UAS has awarded Exclusivity Contracts covering over 100 years to the USA Government; [which means that all the tools, equipments, machineries, vehicles, trucks, cars, building materials and farming tools, tractors [not made in Africa] to be used for the implementation and execution of the entire ACTS' contracts must be [MADE IN USA] products and human labor capacity and know-how needed or required must be provided and supplied by USA, Canada and Mexico] only. This Exclusivity Policy has been initiated because it was only the USA Government that has established U.S. Africa's Infrastructures' Development Fund [USAID-FUND].

UAS has reciprocated in-kind to enhance non-neutral economic partnership with the USA Federal and States Governments which we believe will create more than six (6) million new jobs for the Americans per annum in the USA economy. This policy of [MADE IN USA] only products irrevocably stands because it was only the USA Government and China which had established the U.S. Africa's Infrastructures Development Fund [USAID-FUND] and China-Africa Development Fund [CHAD FUND] when the United States Africa's Development Consortium [USADC] wrote in 1998, and asked the nations of the world to establish their own. When and if the other nations in the Region, establishes its own, its products shall be qualified to be awarded contracts and its products to be used on the ACTS' projects.

Although, the Bureau Trade, Commerce and Industry, is meant for the North American Region, its enabling functional operations and Management Headquarters will be located in Ohio State, USA. I have accepted and approved Mr. Victor Obasuyi's recommendation for Ohio State to be the Regional

Headquarters of the UAS' North American Region. I am asking with our audacity of hope, that we will receive full support and cooperation from your Administration.

Bearing in mind that the UAS is a brand new government of the people, by the people and for the peoples in diversity; with no known reliable-dependable yet, or real revenue generation sources; and because we do need, want urgently, operational funds and functional office tools, computer-equipments, transportation, and sundry materials; we will appreciate any material donations and financial support from your Administration. I can assure you that any gift or support rendered to UAS now by your State and her citizen will be received as investment in future for mutual benefits.

**Very Important Suggestions and Request:**

Because of the relevancy and the importance of economic multiplier impact of value added and for mutual benefits and the built-in non-neutral factor to South Carolina State under the aegis of your Administration, I have no hesitation to suggest that your administration establish its own South Carolina-African Development Commission which will by law, work with the UAS' North American Regional Authority.

Meanwhile, you may want to set up an Executive Committee in your office to work with Mr. Victor Obasuyi.

Apparently-President, Mr. Victor Obasuyi, has informed me that he needs office accommodation. I am asking you [if] your administration can help him to find an office accommodation in your state please.

**NEW ECONOMIC PARTNERSHIP FOR AFRICA'S DEVELOPMENT [NEPAD] COMMISSION**  
**[THE NEPAD COMMISSION]**

The UAS established NEPAD COMMISSION is an autonomous independent Agency with audacity and authority to implement and execute all ACTS' 100 Years' Master Plan and to manage all the contracts that are awarded under the aegis of the Federated United African States Government.

**THE ACTS' 100 YEARS' MASTER PLAN ECONOMIC GROWTH & DEVELOPMENT RECIPROCAL**  
**EXCLUSIVITY CONTRACTS AWARDED TO USA'S FEDERAL & STATES GOVERNMENTS**

1. To design, construct and build 12 lanes 6,869 miles superhighway with railway lines from Dakar, Senegal via all West-African Nation-States with STOP-OVER TERMINAL at LOKOJA in Nigeria en-route to Mogadishu, Somali in East Africa;
2. To design, construct and build 12 lanes of 12,689 miles with railway lines from Cape-Town, South Africa via DR Congo and all other African Nation-States to Tripoli, Libya and Tunisia;
3. To design, construct, build and equip U.S. AFRICAN DEFENSE COMMAN [USADC] POST Headquarters at the First UAS' State at Bakassi which is between Nigeria and Cameroon;
4. To design, construct, build and to dredge River Niger [in Nigeria 269 miles long] one mile wide and 400 feet deep; with four (4) square miles and four (4) hundred deep circular lake for the turn-around ships; to build six (6) miles long each of six (6) harbors along the MAN MADE SEA.
5. To design, construct and build 200 million housing units [both single 3-bedrooms complete and 5 bed rooms complete family sizes] in Africa;
6. To design, construct, build, supply and equip 6 million healthcare hospitals in Africa for the over 200 states in UAS;
7. To design, construct, build, supply and equip 12 million for FREE Primary and Secondary Schools and 150 million 2 PLUS 2 Technical Colleges-Training Institutes in the UAS' states;
8. To design, construct, build; supply and equip 201 states-based Air-ports and 340 International Airports with various capacities in the UAS.
9. To use the USAID-FUNDS to invest in the NEW AFRICA'S WORLD BANK [NAW-BANK];
10. To manufacture and supply as UAS' Partner 10,000 aircrafts; 160 million school buses, 300 million private cars; 100 million buses for public, private tools, equipments and spare parts;
11. To make and supply X numbers of all tools, equipment machines, trucks, vehicles; all construction machines, caterpillars, rollers and graders needed for the construction of ACTS 100 Years' Master Plan.
12. To supply only [NADE IN USA] 6 million mechanized farming tractors, implements and all other specific special farming tools and equipments and materials.

Whereas, the ACTS' 100 Years' Master Plan, as intended to find solution to the African Continent's lack of value added socioeconomics developmental permanent links in character and content of economic growth and prosperity in the past. Because Abuja is the capital of Nigeria and Nigeria is the Host of the African-Nation of the Federated United African States wherein all functional offices of UAS housing will be located. The Global Headquarters of the New Africa's World Bank [NAW-BANK] will be located in Abuja.

Therefore, the below New Nigeria's 10 Year's Master Plan is hereby provided for your perusal. The necessary action which had been taken is as follows:

#### **THE PLAN FOR THE [NEW AFRICA'S WORLD] UAS- NAW CAPITAL CITY**

1. The New UAS'-NAW Capital City plan; to design, construction and development, Offices of the Legislators' 2.6 million office space rooms for Legislators members; Secretariat Buildings and staff space accommodation for the Legislators' staff members;
2. To design, construct and build 3 million Residential Housing units for Legislators and families;
3. To plan, design, build, construct and develop 8 million Rooms, UAS-National and States Secretariat in the Capital City;
4. To design, construct and build 20 million public housing units throughout Nigeria inclusively;

#### **FOR NIGERIA'S NATIONAL INFRASTRUCTURES' TEN YEARS' MASTER PLAN**

1. To Design and build Nigeria's national 12 lanes super highway and fast track-railway line from Abuja via Minna onto Kebbi and Zamfara States;
2. To design and build around Minna 8 lanes Ring Road around Minna city Niger State;
3. To design, construct and build 12 lanes super highway and railway line from Lagos via Abuja and other states en-route to Maiduguri, Borno State;
4. To design, construct and build 3 million of primary and secondary schools in Nigeria.
5. To design and construct Nigeria's 12 Lanes supper highway and fast Track Railway lines from Abuja to Jos; and 8 lanes Ring-Road around Jos city, Plateau State;
6. To design and Build 12 Lanes super highway and fast track railway lines from Abuja to Kaduna [with 8 lanes highway around Kaduna]; the Abuja 12 Lanes super highway with fast track railway lines to Kano and via Kano to Katina State.
7. To design construct and build 12 lanes supper highway with fast track railway lines from Port Harcourt via Abuja en-route to Kano Via Kaduna and en-route to Katina;
8. To design, construct and build 12 lanes supper highway with railway line from Ondo State via other states and en-route to Sokoto, Sokoto State;
9. To design, construct and build 12, lanes super highway with railway lines from Calabar via other states to Kano and Katsina State.
10. To dredge Niger 269 miles long, one mile wile wide and 4 square miles for ships turn around and 12 lanes suspended bridge with 4 separate six miles long harbours along the way;
11. To design and build international air-port capable to handle landing or take off planes in every three minutes.
