Alex Jones, radio host:

"Well folks, what we know from this, is that Tosh Plumlee is someone who's testified repeatedly and been proven accurate before [US] Congress. He's saying he has a high-level NATO source that said that **the [US] State Department was transferring weapons directly to the al-Qaeda forces, the Syrian rebels, and that they basically took out the Ambassador and others because they were complaining.** And that's what I have from other sources as well. But this is from somebody who's talked to the NATO person who witnessed it, and knew about it.

Former CIA contract C-130 pilot / gun-runner William Robert "Tosh" Plumlee (76):

"As far as the **Direct Commerical Sales** [DCS] program, that's been an ongoing program that's monitored, or **controlled by the [US] State Department**. Over the years, I've seen a pattern developing here. I was a C130 pilot, I've flown guns, ammunition [profanity omitted] all over the world. ... **this program [DCS] that is used to ship weapons all over the world**. In my travels, I found out that, it appears to me, in my opinion, **we start the conflict, we escalate the conflict, we supply high impact weapons to both sides of the conflict.** ..."

"... a contact of mine in the Middle East, a high-ranking NATO official, mentioned to me that he had had a report that the Ambassador [i.e., US Ambassador to Libya Chris Stevens] had been complaining about the dispatches and cables that he had sent the [US] State Department about weapons being received and radicals armed, including Stinger Missiles. His question was, 'Where are they coming from?' 'What do I have to do?' 'What should I do?' And he was ordered to stand down. Now this is second-hand information from a very sensitive source. Second time that that happened, was from a very good friend of mine that had worked the Mexico beat [gun-running ?] ...

he was telling me, the second confirmation, that ... the Ambassador's people had written a series of field reports and cable dispatches advising our [US] State Department that the rebel faction had been armed with US weapons. ... I challenge the [US] State Department to release those memos that the Ambassador wrote to them four weeks, two months, before the place [i.e., Benghazi] was attacked. Alex Jones, radio host:

"I have Pentagon sources, who say, well who said a week after [i.e., a week after the Sept. 11, 2012 Benghazi attack] that that's what happened - that the Ambassador ... that the Ambassador was saying 'No' to giving al-Qaeda heat-seeking missiles. And, that they had three warehouses full of them, and so they just ordered 'em all killed [the US Benghazi personnel] using the Benghazi/al Qaeda security force that Obama had hired, and that this was just trying to wipe out the witnesses of the weapons so that they could also then expunge the cables [i.e., Ambassador Steven's cables complaining]. "They were not only saying 'No' to giving missiles to al-Qaeda, that was the second deal. We were giving high impact weapons to the Syrian rebels. Within that group was ... al-Qaeda members ... which pilfered those weapons and used 'em against our people. That's what the story is. That's, in my opinion, is what the coverup is. The story about someone doin' a **film** that made the people go a radical and go crazy there, **was a cover story to cover a top secret ongoing operation of arms shipments to the Syrian rebels**, period, before our President, Commander-in-Chief, decided that we needed to arm the Syrians. I am not a conspiracy person. This information that I got comes from multiple sources.

Alex Jones, radio host:

"... Tosh, from what I've been told, this has finally woken up the entire military. That's why the Joint Chiefs went to Obama and said, you're not gonna attack Syria - we're not backin' al-Qaeda, this is over, the military's on the edge of mutiny. The vast majority of military in polls are against it. All the military I talked to, knows that they were watching live feeds [i.e., of the September 11, 2012 Benghazi attack], or talked to friends that saw live feeds, from the Predators [drones] of the six and a half hour gun battle, as they were ordered to stand down, NATO all saw it, **everybody knows it was a hit.** So here's my question, did they pull off security, and just let 'em kill 'em, or did they order the Benghazi security, the al-Qaeda forces, to go kill 'em, to get rid of the witnesses? Did they let 'em die for a coverup, or were they involved in it? ... And is
