Because there was no written agreement and because of the contractual relationship involved between EMD and the trucking company, it is unclear which entity (state, county, or city) is liable. Therefore, although our position that EMD is not liable is defensible, the recommendation from Sternson and Avant is that it is better to pay the one-third than continue arguing this matter.
