M I N U T E S

PRESENT: Chairman - C. Edward Poore

Mr. Poore called the meeting to order and Councilman David L. Hooper gave the invocation.

On the motion of Mr. Wright, seconded by Mr. Kinley, Council voted unanimously to approve the minutes from the April 7, 1981 meeting as mailed.

Mr. Poore explained the need to fill vacancies on the Planning and Development Board. On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to replace Mr. George Leopard with Mr. John C. Neel, III. On the motion of Mr. Bratcher, seconded by Mr. Rhodes, Council voted unanimously to replace Mr. Frank R. Wrenn, III with Mr. Hack Clinkscales, Jr. of Belton. On the Motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to re-nominate Mr. Tom W. Rutledge. On the motion of Mr. Wright, seconded by Mr. Bratcher, Council voted unanimously to re-nominate Mr. C. R. Johnson, Jr.

Mr. Robert P. Lusk explained to Council that it was necessary to hold a public hearing on the bond issue (Ordinance #63) before third and final reading could be approved. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to hold a public hearing.

Mr. Prue Gilreath presented three plans from the Long-Range Planning Committee for the Anderson-Oconee Council on Aging. Plan number one-County Council provide \$525,000 as seed money to construct 8 multi-purpose senior activity centers. Plan number two-Council provide \$300,000 as seed money to construct 6 multi-purpose senior activity centers. Plan number three-Council to provide \$150,000 as seed money to construct a multi-purpose senior activity center in Anderson. Council received as information.

Mr. David Watson discussed federal regulations regarding the use of Revenue Sharing Funds. It is required to hold a public hearing for citizens to express their concern regarding the use of these funds. There were no comments.

Mr. Curtis Kinley presented Ordinance #65 (Maintenance & Repair of

County Roads). On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to adopt on first reading Ordinance #65.

Mr. Christie, a former guard who supervised inmates at the Anderson County Stockade, denounced a county social services official for accusing the prisoners of sexual misconduct while cleaning a county office building. Mr. Furman Gerrard, a member of the Department of Social Service's Board of Directors, spoke on the subject, also.

Mr. Poore commented on the 15 violations of the state fire code against the County Stockade. Mr. Poore stated that the County did not have funds to bring it up to meet with the state fire code at the present time but he had talked with Representative Dolly Cooper, Representative Pat Harris and asked Representative C.D. Chamblee to bring the necessary papers by his office. Mr. Chamblee did not bring the paper by, but sent them by Mr. Curtis Kinley. Mr. Poore filled out the papers requesting \$15,000 to bring the Stockade up to the State fire codes and mailed the letter to Representative Cooper in Columbia, South Carolina. Council agreed with Mr. Poore comments.

Mr. Lusk explained the various ordinances that the County could enact for the County dog problem. Council received as information.

Council adjourned at 8:00 p.m.
