

This responds to your letter received on April 7, 2009, sent to Jeff Stensland, the Department's Public Information Officer. We have gathered about one hundred (100) pages of information, about sixty (60) of which specifically relate to Bright Start and still have to be redacted of personally identifying information. We also, have about 200 pages of reports that, like our Audits Division's, enclosed, may only mention Bright Start as a one provider of the service or services under review. Thus, the other reports are not specifically directed audits of this provider.

Our expense for collecting, reproducing and mailing all of this information will be about fifty dollars (\$50.00). Unless we hear otherwise from you we will proceed with redacting the personally identifiable information and copying the audits of specific services.
