I'm in the Government Relations office at the Corporation for National and Community Service and I'm writing to see if you might be able to help us secure a proclamation from Governor Haley in honor of Senior Corps week. I've spoken a couple times with Leanna DuPree, who has submitted the proclamation on our behalf. She is not aware of any problem other than our request came in with shorter lead time than the governor's office usually requires.
