I was glad to hear from you last Friday, September 20, 2002, that the State of South Carolina is going to **dismiss all charges** against me this week. However, as you know, you have been telling me that all charges were going to be dismissed the first time I met you **which was several months ago!!!** Isn't this just more of what my metro Atlanta born and reared wife tearfully warned me is just typical “**SOUTHERN BIGOTRY & CORRUPTION?**”

I continue to have several key questions that you have refused to answer.

My fellow West Pointer and great American (**not confederate**) hero William T. Sherman was correct concerning his opinion of South Carolina officials – “**ALL TRASH.**” I certainly hope someone is not stealing bond money from Beaufort County Jail as my crooked former employee **Frank Watson** stole money from my Increte of Lowcountry First Union Bank.
