Surplus Property Public Notice

August 4, 2005

In accordance with the State of South Carolina Statue 57-5-340, by this publication the Department is making public the Surplus Property Real Estate Transactions to the State Highway Commission. The following sheets include a breakdown of surplus property real estate transactions. These transactions may have resulted from negotiations with property owners during right of way acquisition, direct sales, settlement of a condemnation action, and/or corrective actions to previously reported sales.

1. File 10.368A / 18.635 / Road S-62/75 / Charleston County / First District

During construction of improvements on Road S-2028 @ Brandywine Road, under File 10.270A in Charleston County, in the City of North Charleston, the Department acquired right of way for Brandywine Road, by Title to Real Estate from Lane Commercial, LLC dated June 25, 1997 and from A. Douglas Lyke, H. John Lyke and Richard E. Lyke by Title to Real Estate dated June 30, 1997.

The Department requested an exchange of right of way with the City of North Charleston at the intersection of Road S-62/75 (Ashley Phosphate Road) and Brandywine Road. This exchange would give the city ownership to a portion of Brandywine Road which is a North Charleston street. In turn, the City of North Charleston would quitclaim any interest in the old roadbed of Brandywine Road to the Department. Therefore, a Gratis Quitclaim Deed for 0.60 of an acre of land to the City of North Charleston was executed on February 3, 2005.

2. File 23.342A / US Route 25 / Greenville County / Fourth District

During construction of improvements on US Route 25, under File 23.342A in Greenville County, in the City of Greenville, the Department acquired right of way for Road S-86, by The Belt Line Act dated 1945 and accepted into the South Carolina Department of Transportation Highway System on June 27, 1947.

A request was received by the Department from the adjacent landowner asking the Department to convey a section of old abandoned Road S-86. The request was circulated to the Engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.32 of an acre of land to BRC Western Square, LLC was executed on July 11, 2005, in consideration of \$32,500.00.

3. File 26.139B / SC Route 31 (Carolina Bays Pkwy) / Horry County / First District

During construction of improvements on SC Route 31, under File 26.139B in Horry County, near the City of Myrtle Beach, the Department acquired right of way for SC Route 31, by Title to Real Estate from Joseph and Pamela Barnette dated December 10, 2002 and by Quitclaim Deed from Horry County dated April 28, 2004 for Monroe Circle.

During negotiations to settle to difficult acquisition case, the Department agreed to convey the uneconomic remainder of Tract 38 to the adjacent owner in addition to a portion of abandoned County Road (Monroe Circle) as a partial payment for new right of way needed for the above project. Therefore, a Gratis Quitclaim Deed for approximately 0.13 of an acre of land to Joseph R. & Patsy L. Null was executed on July 11, 2005.

4. File 10.134A / Route I-526 / Charleston County / First District

During construction of improvements on Interstate I-526, under File 10.134A, in Charleston County, near the Town of Mount Pleasant, the Department acquired right of way for Route I-526, by Condemnation from Louis v. Vick, Jr. dated December 20, 1995 and from Gloria T. Wiggins by Title to Real Estate dated August 31, 1995.

While constructing the Mark Clark Expressway, the Department placed RC Pipe along Pumpkin Lane as shown on the plans under the premises of a dedicated right of way from the Town of Mt. Pleasant. Since the Town never took over the maintenance responsibility of Pumpkin Lane, the Department found that it was encroaching on the Grantee's property. In order to correct the encroachment, the Department has agreed to convey back the 5-foot strip of right of way previously acquired from the Grantee. In exchange, he has agreed to give a 15-foot Right of Way Easement needed to maintain the current SCDOT pipe on his property and reimburse the Department \$9,700.00. Therefore, a Quitclaim Deed for approximately 0.08 of an acre of land to Louis V. Vick, Jr. was executed on May 12, 2005, in consideration of a Gratis Right of Way Easement and \$9,700.00.

5. File 4223.100B / SC Route 80 / Spartanburg County / Fourth District

During construction of improvements on SC Route 80, under File 4223.100B in Greenville County, near the City of Greer, the Department acquired right of way for SC Route 80, from Kenneth A. Baker by Title to Real Estate dated May 22, 2002, from Larry T. Whitener by Title to Real Estate dated April 30, 2002, and from Roger A. Gruver and Joy Gruver by Title to Real Estate dated May 17, 2002.

The Department negotiated an exchange of property for the new right of way needed for the above project. It was agreed that the Department would sell the remainder of Tracts 8, 10, and 12 to the Grantee in consideration of the right of way and \$22,750.00. Therefore, a Quitclaim Deed for approximately 4.8 acres of land to Greenville-Spartanburg Airport District was executed on July 11, 2005.

6. File 4223.100B / SC Route 80 / Greenville County / Fourth District

During construction of improvements on SC Route 80, under File 4223.100B in Greenville County, near the City of Greer, the Department acquired right of way for SC Route 80, from John F. Gigante by Title to Real Estate dated May 20, 2002 and from Carolyn W. Chapman by Title to Real Estate (Corrective Deed) dated May 6, 2003.

The Department negotiated an exchange of property for the new right of way needed for the above project. It was agreed that the Department would sell the remainders of Tracts 21, and 33 to the Grantee in consideration of the new right of way and \$20,000.00. Therefore, a Quitclaim Deed for approximately 8.3 acres of land to Greenville-Spartanburg Airport District was executed on July 11, 2005.

Professional Services Recommendations

August 4, 2005

The following sheets include recommendations for the Department to utilize professional consulting firms to provide various services, which may include design, right of way acquisitions, construction engineering and inspection, or other associated services. The Department requests approval from the Commission to advertise, select and negotiate for these necessary services.

The Department requests Commission approval to advertise and select engineering firms to provide Construction Engineering and Construction Inspection (CE/CI) services on an "on call" and "as needed" basis statewide. Contracts will be for a period of three years. Services will be performed on those projects which the Department does not have adequate staff and/or expertise to perform in-house.

The Department requests Commission approval to advertise and select individuals or consulting firm(s) for the purpose of providing in cooperation with the Carolinas AGC, a partnering management technique that has saved many millions of dollars and countless amounts of time on projects across the United States. This project will be funded through the various Federal and State programs.

Removal of Roads From State Highway Secondary System

The Department recommends Commission approval for the removal of certain sections of secondary roads from the State Highway Secondary System. These sections of roads may be removed for one of the following reasons:

1. Abandonment of Relocated Section of Highway
2. Deletions and Removal of Roads from State Secondary System - Roads may be deleted and removed from secondary system by exchanging for equal or less mileage or roads, which have a higher traffic importance. Ownership reverts to local government having jurisdiction (city or county). Approval of deletion or removal by local government is not required.
3. Abandonment of Right-of-way - Right-of-way may be abandoned if it is determined that the right-of-way is not required for right-of-way proposes or if the right-of-way is not needed for Department purposes.
