Dear Governor Haley,

I do not know if you can help me or not with the issue I am about to present to you but I am at wits end trying to find a solution to being terrorized. Any assistance you can give will be greatly appreciated.

Let me start by stating that I am a Korean War veteran and while living in your state, I voted for you to become governor and appreciate all of the improvements that you have made.

My problems started when I purchased a property through a Mrs. Connie Martin that works at the South Carolina Bank and Trust in Mortgages Dept. She admonished me to hire her son, Jeffery Charles Martin, to do some temporary work and odd jobs. Over time, he did some work for me and I even tried to help him take some college classes. At the time, I had no knowledge of his criminal past for drug paraphernalia. I paid him daily and had him sign for all of his wages while working for me.

After trying to help Jeffery, I found that all of my records of him working for me and getting paid came up missing from my home. My personal vehicle as well as my home had also been burglarized. I reported this to Orangeburg Police Lieutenant Robinson and the city manager. I also found out about Jeffery's criminal past at this time. The police refused to even make a report of the incidents that were happening at my home. Instead, Lt. Robinson stated the following:

- You will be followed, harassed, and burglarized for the rest of your life
- No one will listen to me or believe me if I report any incidents.
- The police will not do anything to help me to catch the predators that they hire.
- Moving away will do me no good as I will be followed and my life will be made miserable.
- I will be laughed at and to "remember we did not lose the war" Lt. Robinson told me on Sept. 20<sup>th</sup>, 2013.

I also found out that He is affiliated with a gang that cooperates with the local police department. Apparently, the gang leader is an electronics expert which explains how they are able to get into my vehicle no matter how many times I have the locks changed. I have had several silver bars worth 1000 dollars stolen from my vehicle and my home was attempted to be set on fire 3 different times. Yet the police will do nothing about this. Not even a report was filed.

This became so bad that I sold my home in South Carolina and moved to Florida. The last day that we were in South Carolina, the City Manager (who was my neighbor) had Lt. Robinson come speak with me. He told me that "We will be accounted for, for the rest of our lives and that they will keep track of us no matter where we go".

Since we have been in Florida, there have been the following incidents:

- My mail has been stolen.
- My tax documents have been stolen from my home. We notified the IRS
- My trust papers and will have been stolen.
- Someone has tried to cash out my Ameritrade account 13 times.

- He attempted to steal my truck.
- He tried to set my home on fire.
- Our cell phones and computer have been disrupted numerous times. The modem is useless
- Several other items have come up missing from our home.

Needless to say, my wife is a nervous wreck and all of this has affected her health. We are afraid to leave our home unless we have someone to house sit for us. We are to the point that we cannot even have a decent night's sleep.

I realize that there is nothing that you can do about the incidents outside of your state, but I was hoping that there was some way that maybe you can investigate the city government of Orangeburg and perhaps find a way to "call off the dogs" so to speak? We would like to know where the money is coming from to follow us and to continue to burglarize us in Florida. He has previous record of assault and battery.

All that my wife and I want is to live in peace, be able to sleep at night and to live without fear that someone could break in at any time and attempt to do harm to us personally.

Please note: I have even submitted to psychological testing at the VA to preclude anyone trying to say that all of this is "imagined". I have documentation to prove that I am of sound mind with no issues mentally whatsoever. Not senile as mentioned by the Orangeburg police. I know that this is "over the top", but I am very anxious to put all of these incidents behind me and get on with my life in peace

Thank you so much for taking the time to read this. I realize how this may sound and I am certain the city government of Orangeburg will try to brush all of this off as the rambling of a senile old man. I really do not know if there is anything you can do, but I do know that if anyone can address this issue that you can forward this to the right people. All I ask is that you communicate back to me and give me peace of mind that this is being looked into. . Many thanks for your interest!
